# DCMS Statistical Publications: Consultation response summary

## **Response summary**

This report summarises feedback DCMS has received in response to the DCMS Statistical Publications user consultation<sup>1</sup> which ran from 10<sup>th</sup> July until the 7<sup>th</sup> August 2017 and our proposed response. It has been structured to reflect the headings under which views were sought in the user consultation.

## **Overall summary**

DCMS received 16 responses to the user consultation. These were from a range of organisations, including umbrella organisations that represent and/or support large numbers of groups in DCMS sectors, Arm's length bodies, and internal teams in DCMS (see Annex A).

**School Games Indicator:** There was little awareness or use of this publication. The small number of respondents who commented had different views on the impact of discontinuing this publication.

**Entertainment Licensing Statistics:** There was little awareness or use of this publication by respondents.

**Taking Part Quarter 2:** While most respondents stressed the importance of an annual release and continual data collection for Taking Part, most did not make extensive use of the Quarter 2 publication. Some commented that this publication was useful to monitor headline trends in engagement.

**Exports of Objects of Cultural Interest:** A small number of respondents had an interest in this publication and they generally felt that ceasing this publication would have a negative impact on their work as the data would be less timely and less easy to access if it was only available in the annual report on the Export of Objects of Cultural Interest by the Reviewing Committee on the Export of Works of Art and Objects of Cultural Interest.

**Broadband Performance Indicators:** There were no responses to this section of the consultation.

**DCMS Statistical Releases:** Most respondents were positive about the content and format of DCMS Statistical Releases. Several respondents argued that the Heritage sector was understated in Economic Estimates due to the number of codes allocated to the sector under the Standardised Industrial Classification system. A number of other specific comments were made about the content of releases.

Our response to the comments received on each publication is set out below. In some cases this involves reducing or discontinuing some publications in order to free up resource for other priorities and to develop our key outputs, including DCMS sector Economic Estimates, the Taking Part survey and analysis to inform the UK exit from the EU. ## School Games

#### **Consultation questions**

Summary of feedback – School Games

- One respondent felt discontinuing the publication as Official Statistics made sense given this is no longer a stated departmental indicator and nearly 90% of schools were engaged which meant the existing key performance indicator no longer reflected the priorities of the programme.
- One respondent said that, although they were not previously aware of the publication, they felt it contained useful information and were concerned that discontinuing it would remove an accessible form of data they required for their work.

#### Our response

 DCMS will cease publication of the School Games Indicators as this is no longer a departmental indicator and is not widely used. However we will work with DCMS policy colleagues to ensure that they can still access the level of data they need from the key source organisations when required.

Summary of feedback - Entertainment Licensing

Only one organisation responded to this set of questions. This respondent was not
previously aware of this publication but felt the contents were useful.

## Our response

- DCMS will look to de-badge this release from National Statistics to Official Statistics.
- DCMS will continue to publish the total number of premise licenses and club premise certificates on an annual basis but will cease collection and publication of the breakdown by type of premise that has previously been published from when the Home Office next issue the data collection.

#### Summary of feedback – Taking Part

- Most respondents were aware of this publication and had engaged with the contents in their work.
- Around half of respondents made use of the report and spreadsheets/tables. One third of respondents made use of the dashboard and infographics.
- Around half of respondents had used the publication for information on Arts, Heritage, Museums & Galleries, Archives, Digital Participation and Volunteering/Charitable Giving. Around one third of respondents used data on Libraries and First World War.
- Most respondents felt that discontinuing the quarter 2 release would have little or no impact to their work although some felt it was important to be able to monitor headline trends.
- Data identified as being essential by respondents were: on site and online engagement statistics, Heritage, Museums, Digital Participation and public library use.

#### Our response

- DCMS will replace the detailed quarter 2 release with a mid-year dashboard, which will allow users to continue to monitor trends at a high level.
- DCMS will continue to collect Taking Part data throughout the year and will publish detailed annual reports covering the adult and child data each Summer. In addition DCMS will publish a series of Focus reports during the year (generally in April and October).

#### **Objects of Cultural Interest**

#### **Consultation questions**

19. The Exports of Objects of Cultural Interest was last published on 15<sup>th</sup> December 2016. Were you aware this had been published?

20. Have you used this publication at all? By 'used' we mean engaged with the contents of the release to inform your work or areas of interest.

#### Summary of feedback

- Respondents were aware of the publication and engaged with the content in their work.
- Respondents suggested if this publication were not available they would have difficulty in advising on exports reform; sharing information with the Heritage sector; and accessing data in a format that allowed for easy analysis.

#### Our response

DCMS recognise the value some respondents place on this statistical release. However, given
resource pressures and the availability of these figures in the annual report of the Reviewing
Committee on the Export of Works of Art and Objects of Cultural Interest, DCMS plans to
discontinue this statistical release.

#### Summary of feedback

- Taken together, all of the listed statistical releases were used by respondents.
- Most respondents felt that the content of releases provided sufficient information.
- Several respondents were concerned that the Heritage sector was understated in the DCMS Sector Economic Estimates due to classification under the Standardised Industrial Classification system.
- Other issues on content raised by individual respondents included insufficient data on non-national museums; greater granularity for film/screen sector; and more focus on issues around wellbeing.

- Most respondents found infographics and spreadsheets/tables as being the most useful elements of publications. Taking Part Online Tools were also highlighted as being beneficial.
- Most respondents heard about DCMS statistics through twitter, gov.uk and our newsletter.

#### Our response

- DCMS will continue to publish all releases and ad hocs on gov.uk and will inform users of new releases through twitter and DCMS newsletters.
- Where appropriate, DCMS will look to use infographics to supplement the main statistical reports.
- DCMS will continue to define its sectors using Standard Industrial Classification codes. It is recognised that these have limitations which we have highlighted in our DCMS Sectors Economic Estimates reports. We will however make this clearer that using one SIC code to represent the Heritage sector may be an underestimate for the sector.
