INTRODUCTION

This memo provides guidance on the Social Security (Qualifying Young Persons Participating in Relevant Training Schemes) (Amendment) Regulations (SS (QYPPRTS) (Amdt) Regs 2017) (S.I. 2017 No.987) and come into force on 6.11.17¹.

BACKGROUND

These changes insert a new definition of a relevant training scheme¹ into the UC Regulations and ensure that a qualifying young person (QYP – see ADM <u>E2092</u> - 93) participating in such a scheme under the 'Youth Obligation' is not prevented from claiming UC by virtue of the rules relating to receiving education (see ADM <u>E1013</u>).

DEFINITION OF RELEVANT TRAINING SCHEME

- 3 Relevant training scheme means:
 - 1. a traineeship¹, or

- 2. a course or scheme which
 - 2.1 comprises education or training designed to assist a claimant to gain the skills needed to obtain paid work (or more paid work or better-paid work) and
 - 2.2 is attended by a claimant in the AWRR group² as a work preparation requirement or as a voluntary work preparation, **and**
 - **2.3** the claimant has been referred to by the Secretary of State.

Example

Pawel is aged 18 and has an award of UC. He lives in a digital/ full service area. Pawel is a QYP in the AWRR group. He is undertaking a number of training courses as directed by his work coach under the Youth Obligation scheme. As Youth Obligation training falls within the definition of a "relevant training scheme", Pawel is not deemed to be 'receiving education', so does not fall foul of the 'education condition' and is still able to claim UC..

MISCELANEOUS CHANGES - NEW STYLE JSA AND UC

Where the definition of "traineeship" appears in the regualtions¹, the 'Chief Executive of Skills Funding' is amended to 'the Chief Executive of Education and Skills Funding'.

SAVINGS

- The changes in this memo do not apply to a UC award unless it is one described in paragraph 6.
- 6 The awards are
 - an award made to a person who at the time was living in a digital service area (known as the Full Service), whether or not they are still living there or

- 2. an award made to a person who is living in a digital service area, whether or not they were living there when the award began or
- 3. an award, other than in .1 or .2, made to a person who has lived in a digital service area at any time after it became a digital service area, but only if the award has been administered on the digital service computer system or
- 4. an award, other than in .1 .3 made to
 - **4.1** members of a couple where a previous award ended on formation of the couple **or**
 - **4.2** a single claimant where a previous award ended when the claimant ceased to be a member of a couple

and the previous award was administered on the digital service computer system¹.

- 7 A digital service area is¹
 - 1. postcode districts SM5 2, SM6 7 and SM6 8 (i.e. the No. 28 and 50 relevant districts) and
 - 2. one where
 - 2.1 no restrictions have been imposed on who may claim UC apart from the requirement to live in the relevant district, and the date from or period for which UC is claimed or
 - **2.2** restrictions on who may claim UC previously imposed have been removed.

The digital service computer system is the computer system which is operated on behalf of the SoS in digital service areas¹. See ADM Chapter M5 for more information on digital service areas.
