- 2. There shall be created to the reasonable satisfaction of the authority an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order.
- 3. The Cumbria County Definitive Statement shall be modified as described in Part 3 of the Schedule to this Order.
- 4. Despite this Order all statutory undertakers shall continue to have any existing rights of access to and egress from any apparatus, equipment and plant accessible only from the right of way referred to in Part 1 of the Schedule to this Order.
- 5. The diversion of the footpath shall have effect on the confirmation of the Order and shall be cited as the Cumbria County Council (Footpath No 431024 Parish of Whitehaven) Public Path Diversion and Definitive Map and Statement Modification Order 2017.


