Information request

I would like to know the number of people claiming Employment and Support Allowance (formerly Incapacity Benefit) deemed fit to work by Atos for the years: 2009, 2010, 2011, 2012, 2013, for the Weymouth and Portland and West Dorset administrative areas.

I would like to know, of these deemed fit to work, how many had their Atos decision overturned by the DWP.

DWP response

Please note that DWP does not 'overturn' Atos 'decisions' but makes decisions based on advice/recommendation of Atos, who carry out the assessments.

Anyone claiming Employment and Support Allowance (ESA) will undergo the Work Capability Assessment (WCA). The WCA is based on the premise that eligibility should not be based on a person's condition, but rather on the way that condition limits their functional capability. Following the WCA, Atos Healthcare's Healthcare Professional (HCP) provides a recommendation of the claimant's eligibility for ESA. The final decision on ESA benefit entitlement is made by a DWP Decision Maker (DM) informed by advice from the Atos Healthcare's HCP and other available evidence.

In response to your query, the table below shows the number of ESA DM's decisions compared to the recommendation made by Atos Healthcare's HCP in Weymouth and Portland and West Dorset local authority areas, for claims made in the period January 2009 to September 2013, which is the latest information available.

Please note that the figures supplied are derived from unpublished information and have not been quality assured to National Statistics or Official Statistics publication standard. They should therefore be treated with caution.
