Thank you for your email of 21st September 2017 requesting the following information:

I am filing a request to be informed of:

- A) the cost of a single SA80 rifle or the costs of each type of rifle i.e. L86 LSW, L98A2 Cadet GP Rifle, L85A2 IW, L22A2 Carbine and L85A2 Carbine
- B) The total cost of the SA80 A2 upgrade by Heckler & Koch.
- C) The expected cost of the upcoming SA80 A3 mid-life upgrade
- D) the annual costs of running and repairing existing SA80 Rifles

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held.

The information you have requested can be found below, but some of the information falls entirely within the scope of the absolute exemption provided for at section 21 (Information Reasonably Accessible to Applicant) and the qualified exemption provided for at section 43 (Commercial Interests) of the FOIA and has been withheld.

Section 43 is a qualified exemption and is subject to public interest testing which means that the information requested can only be withheld if the public interest in doing so outweighs the public interest in disclosure.

Section 43 (2) considers information which if released is likely to prejudice the commercial interests of any person. A person may be an individual, a company, the MOD, or any other legal entity. Disclosing the information requested would be considered a breach of commercial confidentiality. This could result in other companies being reluctant to provide commercially sensitive information to the MOD. It could also be seen to prejudice any future competitive exercises undertaken by the MOD or the contractor.

The responses to your questions are as follows:

A) The information requested is being withheld under S21 (Information Reasonably Accessible to Applicant). The information has already been published and can be found at the following link: https://www.gov.uk/government/uploads/system/uploads/attachment_data/file/654131/2017-07603.pdf

- B) £111m (ex VAT).
- C) The long term programme assumptions are still being modelled and we are, therefore, unable to provide realistic cost estimates at this time. However, the expected cost of the initial 5,000 weapons is £4.4m (ex VAT).
- D) Information withheld under s43 (Commercial Interests).
