Iraq

Introduction

1. Council Regulation (EC) 1210/2003 ("the Regulation") imposing financial sanctions against Iraq has been amended so that an asset freeze no longer applies to the entity listed in the Annex to this Notice.

2. The following entry has been removed from the consolidated list and is no longer subject to an asset freeze.
 - IRAQ REINSURANCE COMPANY (Group ID: 7811)

Legislative details

3. On 2 December 2017 Commission Implementing Regulation (EU) No 2017/2217 ("the Amending Regulation") was published in the Official Journal of the European Union (O.J. L 318, 2.12.2017, p.23) by the European Commission.
4. The Amending Regulation amended Annex III to the Regulation with effect from 3 December 2017.
5. The Amending Regulation reflects the decision made on 24 November 2017 by the United Nations Security Council (UNSC) Committee to remove 1 entry from the UN Regime list.
