Thank you for your email of 3 November in which you requested the following information:

1. *How many soldiers aged 40 years and over attended the Platoon Sergeants Battle Course at the Infantry Battle School, Brecon between January 2013 and now, and how many of these soldiers passed the course?*
2. *What was the average age of soldiers who attended the Platoon Sergeants Battle Course between 2013 and now?*
3. *What was the average age of soldiers who attended the Section Commanders Battle Course between January 2013 and now?*

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held and has been provided below. Information relating to the Platoon Sergeants' Battle Course includes those attending the Tactics Phase 2 or the Live Fire Tactical Training Phase 2. These are two separate parts of the Platoon Sergeants' Battle Course. Some soldiers may only need to attend one part.

In answer to part one of your request, the number of Army soldiers who took either phase of the Platoon Sergeants' Battle Courses, between January 2013 and 3 November 2017 is five. Less than five Army soldiers passed either phase of the course. Please note that figures have been rounded to the nearest five.

In answer to part two and three of your request, the average age of soldiers who attended the Platoon Sergeants' Battle Course between 2013 and the present was 29 years old. The average age of those attending the Section Commanders' Battle Course was 26 years old. Unrounded figures were used in the calculation of percentages.

The figures above are single service estimates only and are not official statistics produced by Defence Statistics.
