# Huge response to advert has been 'fantastic'

The first round of recruitment outside the Maritime & Coastguard Agency has seen a massive amount of interest with more than 300 applications submitted for the marine surveyors.

It follows the completion of our internal recruitment processes with new terms and conditions under the Survey & Inspection Transformation Programme (SITP). All existing MCA marine surveyors have been offered new contracts through that.

These terms and conditions introduce new ways of working aimed at making the way the MCA works more flexible and more responsive to what you the customer has asked for.

Katy Ware director of maritime safety and standards, said: 'Having completed this stage, we wasted no time in launching our first external campaign for marine surveyors and this has now almost finished.

'I was delighted with the response to the advertisements, with over 330 applications submitted. This is the first of a number of campaigns, so I would encourage anyone interested in a career at the MCA, as a surveyor, to register with Civil Service Jobs and keep an eye out for further campaigns in the coming year.'

In Spring 2018, we will be launching a customer survey to get your feedback on how we deliver our services. This will be delivered through an independent third-party organisation and will be short and simple to complete.

The information from this will influence and inform where and how we need to target improvements and so please do take the time to fill it in - it will help us to find out how we can better help you.

# New marine office on the way

A former NHS site in Colchester is going to become the new hub for the marine office in the east of England.

You told us that you wanted a hub in that area - we've listened and are now working towards getting the new facility ready.



We wanted to find a location that would work for people across the region, from the Wash in the north, to the Thames in the south.

Back in March, the Maritime & Coastguard Agency formally approved the plan to buy the former NHS site in Shrub End, Colchester.

Work continues to move MCA staff in to the new hub as soon as possible.

A Marine Information Note (MIN), with full details of the changes, will be published in due course.

### **Digital Solutions**

We're currently looking at digital solutions for many of the services we deliver. This will need some changes to our technology and software but we're working on that. We've changed contracts to bring more flexibility. The formal roster pattern for 7 day working week is now in place. This is in addition to the 24/7 cover already available through the duty surveyor system of course.



# Meet the Graduate Surveyor: Olawale Adeniron

I'm a surveyor currently working in the Tyne/ Beverley area, although I will join the team in the East of England and will be based at the new Marine Office in Colchester.

I joined the MCA as a graduate trainee surveyor after completing a Degree in Marine Technology at Newcastle University. With no sea-going experience, my first few months with the agency were certainly challenging, but over the next two years, through training and mentoring, and working alongside some of the best surveyors in the agency, I became fully trained to conduct surveys and inspections. The training also included a number of courses and industry placements which helped me too.

One of the best part of being a surveyor is the variety of jobs we do. One day you're working on a <10m fishing vessel and the next you are on a 30,000t super tanker.

Another rewarding aspect of my job is working with certain sectors of industry, educating and promot-
