Dear

Thank you for your e-mail of 21 September asking for information about the RAF's VIP Voyager. You requested the following information:

"...details of the costs of the VIP flights made by Voyager ZZ336, since the RAF refuelling aircraft was refurbished to carry members of the royal family and senior members of the Government.

Following a previous FOI request (attached - Ref 2017/8146) I have a list of the VIP flights made by Voyager and would like the individual costs of each of the 12 flights listed.

Could you also send me details of the refuelling trips the aircraft has made since August 9, 2017, giving details of the date it flew, whether it was an operation or exercise, and if it refuelled a UK or foreign aircraft.

I would also like the cost of the refuelling flights undertaken by the aircraft from, and including, July 12, 2016 to the date of this request.

If individual costs for the flights are not possible could you give an overall cost figure. I have also attached a previous FOI request (Ref 2017/7928) which lists refuelling flights from July last year until August."

I am treating your correspondence as a request for information under the Freedom of Information Act 2000. A search for the information has now been completed within the Ministry of Defence, and I can confirm that some information in scope of your request is held.

Firstly, I should point out that the MOD does not routinely record the cost of either individual flights or individual aircraft. We therefore do not hold information relating to the cost of the VIP Voyager being used in its refuelling role. That having been said, the MOD seeks re-imbursements of costs for the use of Voyager ZZ336 in the VIP role based on an agreed charge which covers elements such as engineering costs, aviation fuel, manpower costs and other variable local costs such as landing fees, handling or parking.

Travel costs for Ministers and the Royal Household including the use of Voyager are withheld under Section 21 (*Information reasonably accessible to the applicant through other means*) as they are available on line and can be found at the following links:
