### <u>Item</u> <u>Discussion</u>

#### 1. General Items

- **a. Introductions and apologies**. The Chairman welcomed everyone to the meeting and apologies confirmed.
- **b. Minutes of last meeting/Matters arising**. The minutes of the last meeting had been circulated.
- i. Guest speakers. Unfortunately during to Rail problems there were no speakers available. Next meeting Steve Lowe from project NOVA will be invited.
- c. Annual Report/Recruiting 2018.
- i. The Annual Report was touched on at the last meeting. The Chairman brought members up to date
- ii. We have had one resignation, one new applicant and one member who needs to extend. Members were encouraged to identify any potential new members.
- d. Members reports from external events.
- i. Again it was identified that there are too many military charities. Mick Walters briefed members as to developments at 'homes for veterans'. They now have 15 houses available, a healthy bank balance and during the year they had helped 50 veterans.
- ii. Robert Mortimer reported that the RBL had become the overarching Chair of all military charities.

**Action point.** Robert to report back with details of this new initiative and which charities are involved.

iii. Negative publicity was discussed and how the alleged bad news stories sometimes lacked credibility. Not always possible to refute these allegations.

**Action point.** Policy and Governance group to investigate negative press.

- iv. Andrew Melville attended a Northumbria University presentation about the Northern Hub and that alcohol abuse amongst service personnel highlighted that veterans had difficulties in navigating the system. - v. Veteran's mental health teams could help in this area. What are the main priorities? All 13 VAPC's represented on the Veterans Gateway so should coordinate our input.
- vi. Independent Medical Health Group. The Chairman reported on compensation items. Highlighted that MSK injuries are the 2<sup>nd</sup> largest claim area.
- vii. Alex Baxter reported on NE Lincolnshire Local Authority initiative. One major building had been identified as capable of accommodating all partners involved in implementing the AF Covenant. It contains a coffee house etc. and is able to sign post veterans to the various agencies.

**Action Point.** The possibility of holding our next meeting in this building in Cleethorpes is to be investigated and the Chairman is to approach VWS to confirm.
