#### INTRODUCTION

This memo gives guidance on the application of The Universal Credit (Claims and Payments)(Scotland) Amendment Regulations 2017 (S.S.I 2017 No. 436) which come into force on 31.01.18.<sup>1</sup>

#### WHO THIS GUIDANCE APPLIES TO

ADM memo <u>26/17</u> gave guidance on twice-monthly payments of UC and direct payments for rent and services for a person applying for or awarded UC who resides in Scotland (and any one of the members of a couple living in Scotland who jointly have been awarded UC). This memo amends the guidance given in ADM memo <u>26/17</u>.

# PERSONS TO BE ABLE TO REQUEST TWICE-MONTHLY PAYMENTS

From 31.01.18, the guidance given in paragraphs 4 – 8 of ADM memo 26/17 also applies to awards of UC made before 04.10.17, applications for an award of UC made before 04.10.17 or an award made as a result of an application for UC made before 04.10.17, and an award of UC which is administered on the digital service computer system used in digital service areas because of a decision to transfer the administration of the award to that system from another system<sup>1</sup>. The guidance given in paragraph 3.3<sup>2</sup> and 3.4<sup>3</sup> of ADM memo 26/17 still applies.

From 31.01.18, the guidance given in paragraphs 10 – 15 of ADM memo <u>26/17</u> also applies to awards of UC made before 04.10.17, applications for an award of UC made before 04.10.17 or an award made as a result of an application for UC made before 04.10.17, and an award of UC which is administered on the digital service computer system used in digital service areas because of a decision to transfer the administration of the award to that system from another system<sup>1</sup>. The guidance given in paragraph 3.3<sup>2</sup> and 3.4<sup>3</sup> of ADM memo <u>26/17</u> still applies.
