10 The Data Protection Act 1998

The Environment Agency is responsible for improvements in navigation and the registration of boats on waters for which we have responsibility. We will process the information you provide so that we can deal with your application for boat registration, make sure you keep to the conditions of the registration, and process renewals.

We may also process or release the information to:

- offer you documents or services relating to boat safety, navigation and environmental matters;
- consult the public, public organisations and other organisations (for example, the Health and Safety Executive, local authorities, the emergency services, the Department for Environment, Food and Rural Affairs) on boat safety, navigation and environmental issues;
- carry out research and development work on environmental issues;
- prevent anyone from breaking environmental law, investigate cases where environmental law may have been broken, and take any action that is needed;

- assess whether customers are satisfied with our service and to improve our service; and
- respond to requests for information under the Freedom of Information Act 2000 and the Environmental Information Regulations 2004 (if the Data Protection Act 1998 allows).

We may pass the information to our agents or representatives to do these things for us.

Explanatory notes

Registration charges and payment

All vessels are registered in accordance with The Environment Agency (Inland Waterways) Order 2010.

The full registration charge is payable for a vessel kept, used or let for hire on our Anglian Waterways at any time during the registration year (1 April to 31 March).

When registering the vessel, you are responsible to pay the full registration charge.

There are no options to register unpowered vessels for less than the full registration charge except for those visiting our waterways.

If you sell the vessel or it leaves our waterway, you may qualify for a refund. Refunds are only made in certain limited cases (see www.gov.uk/register-a-boat or call for our refund guidance).

If you sell the vessel or it leaves our waterway and are paying by Direct Debit, there may still be an outstanding balance. If you cancel your Direct Debit before the final instalment is paid, we may invoice you for the outstanding balance.

Tender discount

If your main boat is registered, a 50% discount applies to the tender. We define a tender as a small boat or dinghy, towed or carried by another boat.

Youth organisation/clubs discount

A 75% discount applies to unpowered vessels owned or controlled by youth organisations or sporting clubs (under 18s only).

Use of an engine

All vessels fitted with engines – inboard or outboard, even if only occasionally – are classified as powered vessels and must be registered as such before being used, kept or let for hire on the Anglian Waterways.

Navigation key

Vessels navigating our rivers need a navigation key, available from us, or one of our agents. These keys will be required to operate locks and/or provide access to facilities such as slipways.

River Advice for Boaters (RAB)

We encourage all river users to sign up to receive our free ‘River Advice for Boaters’ messaging service, which is currently available on the Rivers Ancholme, Nene and Great Ouse. We will call your mobile and/or your landline via an automated service which can send voice messages at any time. Once signed up for the voice message service, we can also issue text messages and emails.

Third-party insurance

We recommend all unpowered vessel owners have insurance which covers third-party liabilities of at least one million pounds. We do not need to see a copy of the insurance certificate.

Registration plate

Valid only for the vessel in respect of which it has been issued; it is not transferable. It is a legal requirement for it to be displayed upon the vessel to which it refers in a clearly visible position.

Other registration options

Members of British Canoeing or Canoe Wales can use our waterways as part of their yearly membership fee. They are required to carry their membership card with them as it acts as a registration too. Affiliated clubs through British Canoeing and Canoe Wales may purchase registrations for club owned boats through British Canoeing and Canoe Wales or can purchase registrations directly from us. Members of the Scottish Canoe Association and the Canoe Association of Northern Ireland must apply for registrations through us.

Members of a British Rowing affiliated club should register their boats with British Rowing at a reduced rate. This should be done through their club.
