The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty. Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

Section 1: Principles Of The Armed Forces Covenant

1.1 We **Versorium Ltd** will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:

- *no member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen*
- *in some circumstances special treatment may be appropriate especially for the injured or bereaved.*

Section 2: Demonstrating our Commitment

2.1 **Versorium Ltd** recognises the value serving personnel, reservists, veterans and military families bring to our business. We will seek to uphold the principles of the Armed Forces Covenant, by:

➤ ***Promoting the fact that we are an armed forces-friendly organisation;***

- *promoting our work, activities and events through our own digital & social media channels including our website.*
- *publishing our Covenant pledge on a dedicated Covenant page on our website and social media platforms.*

➤ ***Seeking to support the employment of veterans young and old;***

- *We will ensure we advertise vacancies through such medias as the Career Transition Partnership (CTP), LinkedIn and Relevant Job Board Communities to ensure employment opportunities are made available to Veterans welcoming applications from Veterans who meet the criteria in the job specification, recognising military skills and qualifications in our recruitment and selection process*

➤ ***Striving to support the employment of Service spouses and partners;***

- *Welcome applications from spouses/partners who meet the criteria in the job specification and assist them with CV Writing and interview advice.*
- *Endeavour to offer a degree of flexibility in granting leave for Service spouses and partners before, during and after a partner's deployment*

- *Assist Spouse or partner if relocating to a new area.*

- ***Seeking to support our employees who choose to be members of the Reserve forces, including by accommodating their training and deployment where possible;***
 - *Provide up to 2 weeks per year of special paid leave to attend annual training camps*
 - *Accommodate Reserve training commitments wherever possible, support and accommodate mobilised deployment of Reservist employees if required*

- ***Offering support to our local cadet units, either in our local community or in local schools, where possible;***
 - *Provide up to 2 weeks per year of special paid leave to attend annual training camps and courses*
 - *Accommodation of Cadet training commitments where possible, considering sponsorship bids to support worthwhile Cadet projects*

- ***Aiming to actively participate in Armed Forces Day;***
 - *Promote through the web, social media, membership, and other networks*
 - *Publishing stories on the web, social media, through our own membership and other networks as well as working with the RFCA Communications lead & the press*

- ***Offering a discount to members of the Armed Forces Community;***
 - *We can offer support to Defence personnel regarding their CV's when applying for positions through our company.*

- ***Additional commitments;***
 - *Encourage and support employee fundraising for service charities*
