

Annex A: Application questions, criteria and scoring

Applicants to the Trusted Relationships Fund should submit an Expression of Interest through the Crown Commercial Service eSourcing suite.

To help you prepare your Expression of Interest, outlined below are the criteria for this stage, questions you will need to answer against each criterion, the weighting of the criteria and the scoring methodology that we will use to assess your application.

Additional questions about your project and estimated costs are included on the application form, but these are for information only and are not included in the assessment at Expression of Interest stage.

Criteria: Project deliverables and outcomes Weighting: 50

- 1. Please provide an overview of the work you intend to deliver, including:
 - aims of the project and how these will meet the overarching objectives of the fund outlined in the prospectus;
 - outputs;
 - number of young people supported, the nature of this support, and their age range;
 - intended outcomes (specific, measurable, realistic, timescales). These should include outcomes for young people but may also include wider outcomes, for example system or workforce capability;
 - how the project will contribute to the evidence base on what works to protect young people at risk of these types of abuse and exploitation. (500 words)
- 2. Please explain your theory of change why do you think the outputs will lead to the outcomes listed? Is this based on existing evidence, or is this testing a new theory? (300 words)

2	Applicant presents weak evidence for need and additionality; unclear how the project will add value over existing structures; limited local evidence to support proposals, gaps in knowledge are not acknowledged or likely to be filled by the project.
1	Applicant demonstrates insufficient evidence for need and additionality; unclear how the project will add value over existing structures; no local evidence to support proposal; gaps in knowledge are not identified.
0	Applicant presents no evidence for need and additionality; no suggestion of how the project will add value over existing structures; no local evidence and gaps in knowledge are not identified.

Criteria: Partnership working Weighting: 20

2	Applicant presents limited plans to work with partners to receive referrals, to deliver interventions together, and/or to provide additional support to young people involved in the project.
1	Applicant presents very limited plans to work with partners to receive referrals, to deliver interventions together, and/or to provide additional support to young people involved in the project.
0	Applicant presents no credible plans for working with other local organisations in the delivery of their project.
