An innovative approach to ensuring small and local businesses are given a fair chance to bid for contracts is paying off for LLWR – little over a year after the fledgling Business Services Marketplace (BSM) was launched.

Of the 75 individual suppliers that have registered for BSM so far, 60% are classed as Small to Medium Sized Enterprises (SMEs). and 45% are local to Cumbria. Some 17 contracts have been awarded under BSM and 10 of these have gone to SMEs and 11 are local to Cumbria.

"We are really pleased with these figures, they would have been unachievable before the launch of BSM," said Tom Crowe, LLWR's Head of Procurement.

"BSM produces a 'level playing field' for suppliers, making it easier for smaller businesses to interact with SLCs (Site Licence BSM, they can reapply after 30 days, and qualification is open for the full four years of BSM's operation, so suppliers will not be locked out at any stage."

LLWR pioneered the BSM approach for the NDA estate and initially rolled it out as a pilot scheme.

But it has now been adopted for use by the entire estate, with Sellafield, NLL and Magnox all looking to place work through it, while NDA has already done so. BSM is known as a Dynamic Purchasing System under which LLWR splits its procurement into 13 areas, covering all facets of the business.

Firms join BSM through self-certification, which reduces costs and broadens its appeal, and when a piece of work arises in one area. all businesses registered in that sector are invited to bid for the work, broadening the supply chain

Following in-depth evaluations of five submissions by technical and commercial evaluation teams, the first contract awarded Companies). The extensive Programme, which includes the construction of new vaults and a final cap, is the biggest yet undertaken by LLWR and residents will get the chance to study plans in detail on Saturday, 14th October.

An exhibition will be held in the newly refurbished Eskdale Court, at Greengarth Business Park, and residents will also get the chance of a coach tour of the Repository Site, to practical terms. The tour will include a visit to illustrate the organisation's plans in more

Cath Giel, Head of Public Affairs, at LLWR, said: "There's an opportunity to visit Eskdale Court and meet the project team responsible for delivery and discuss proposals for work on Site over the next decade and beyond. Members of our community can talk to members of our team to air any concerns, and be talked through issues such as the height of the final cap, the volume of material required and how it will be transported to Site. This Programme incorporates the biggest single period of construction that we've yet entered into, as it will include the building of future vaults."

Invitations have been extended to the local community and elected representatives, and Eskdale Court will open to visitors at 10am.

Residents who wish to tour Site must register with LLWR ahead of the date. Flat, practical shoes will be required for Site and admittance is conditional on displaying photo ID, such as a passport or driving licence.

Noise barrier installation will precede construction work under Tranche 1 of the Programme. Over the next decade, containers will be transferred from Vault 9 to Vault 8, Drigg Stream will be diverted and a new perimeter drain constructed, and void fill materials will be imported to Vault 8. A final cap will then be installed over Vault 8 and adjacent trenches.

The Programme has 8 tranches incorporating construction of Vaults 9A, 10 and 11 and a final cap over these vaults and adjacent trenches.

Timely move to CLOCS put us on the right road

The Engineering, Design and Construction Framework (EDCF) team at LLWR has signed up to become a CLOCS champion.

Construction, Logistics and Cyclists Safety (CLOCS) was launched by Transport for London following a review of the construction sector's transport activities in 2012. Primarily set up to understand the causes of collisions between vehicles and pedestrians, it has since been broadened to cover the safety of all vulnerable road users. CLOCS aims to reinforce a road safety culture of vehicles working on sites and those visiting or making deliveries, so is applicable to the LLWR Site.

Road safety and respect for other road users is particularly important to LLWR due to the site's location, close to Drigg.

To help us embed the culture CLOCS has developed a Standard for construction logistics: managing work related risks. This is a common standard that brought together 11 existing standards, codes of practice and policies. Within this standard are 14 areas to attempt to comply with including traffic routing, site access and egress, and warning signage on vehicles. CLOCS is championed by the Considerate Constructors Scheme, of which the EDCF is a member.

Type B Packaging Programme on move

The landmark first active shipment of waste to Sellafield from the Magnox Ltd Harwell site in Oxfordshire has been completed under LLWR's multi-million pound Type B Packaging Capability Programme.

LLWR's Type B (Novapak) project team was on hand to witness the historic initial delivery of intermediate level waste to Sellafield in the first pair of high-specification stainless steel transport packages manufactured by Cumbrian firm Bendalls Engineering at Carlisle.

"This is a key milestone for the NDA estate," said Marc Goodwin, LLWR Project Support. "The first pair have now returned empty to Harwell, to successfully complete the first full cycle.

"We have made sure that communications between all sites involved is good, so we can all share learning and openly talk about improvements that could be made to make operating the Novapaks as efficient as possible. Collaborative working with all stakeholders has been key throughout all stages of the project."

The delivery of the second pair to LLWR will signal a re-start of transports by rail of legacy Plutonium Contaminated Materials from the LLWR Site for storage at Sellafield, which had been on hold until the Novapaks were available Inactive handling trials will start in mid-September, before they enter service.

Alan Jackson, LLWR Programme Manager, said: "It has taken us 21/2 years to get to this point, and it has been a huge team effort, involving Sellafield, Magnox Ltd Harwell, ourselves, Bendalls Engineering and the Design Authority Nuvia. We've had a few issues along the way,

but it's the attitude that counts and the team was always motivated to solve any problems and make progress. They've had a steely determination which was nice to see."

Bendalls won the contract to produce six pairs of Novapaks, which will be in operation for a minimum of 8 years. Each package, around 2m³, will carry up to four, 200 litre drums of material.

Simon Williams, of Bendalls Engineering, said: "Turning ideas and design into an actual manufactured high specification piece of kit is always a challenge. By working closely with the LLWR team and the Design Authority, we have together reached this significant milestone and captured a lot of learning and experience that can be applied to the remaining pairs yet to be manufactured."

In addition to supporting manufacture, Nuvia, through commercial arrangements with LLWR, will support the Novapaks' full life cycle operation.

Tom Crowe, LLWR's Head of Procurement, said: "This is the biggest event of its kind that LLWR attends, and it gives members of the Procurement department the opportunity to network with the extended supply chain face-to-face. Over 1,500 delegates attend every year, and it's always a professional, well-run event that proves beneficial to both LLWR and the supply chain."
