Risk Based Approach Implementation Programme Progress

The following document provides a list of Risk Based Approach (RBA) reports that have been submitted, reviewed and accepted by the Department as part of the RBA Implementation Programme. This document will be updated at the beginning of each calendar month confirming the RBA reports accepted by the Department.

The Department has two acceptance categories, based on whether the Department may wish to undertake modelling at the substance level for added chemicals (qualified acceptance), or whether the Department is content that no additional modelling at the substance level is required (unqualified acceptance). Where it is indicated that additional studies may be required, the Department has determined that these studies could benefit from additional modelling of added chemicals at the substance level but would wish to collate evidence from other RBA assessments before commissioning such studies.

Decisions relating to the further studies and future produced water assessment and management policy will be discussed with operators and implemented prior to the OSPAR implementation deadline of 31 December 2018.
