# Agenda item 1 - Welcome and introductions and minutes of previous meeting

1. The minutes of the previous meeting were agreed.

### Agenda item 2 – MAC, Home Office and MAC secretariat updates

- 2. Paul Regan gave an update on behalf of the Home Office. Including the latest stage of negotiations on the UK exit from the EU, net migration statistics and the Tier 2 Visa cap.
- 3. Jennifer Bradley gave the update on behalf of the MAC Secretariat. We are awaiting new laptops to increase capability.
- 4. Alan Manning has met a number of Secretaries of State including Jeremy Hunt and Immigration Minister Caroline Noakes. Madeleine Sumption said the Migration Observatory was currently looking at settled status registration – looking at different groups of people who may have trouble navigating it and also the tier 2 cap. Jo Swaffield raised a discussion on the Panorama TV programme on migration in the past week; the response to migration from many in the public was negative when followed up with questions on jobs and who should be able to work in the UK the views changed. This highlighted the need for data and evidence to inform the public debate.

## Agenda item 3 - Update on MAC International Student Commission

5. Harriet Cameron gave an update on the call for evidence responses to the International Students commission. The responses have been collated and reviewed, a summary paper has gone to the Committee. In addition, there have been round tables with higher education providers. Harriet gave an overview of the responses and the views they contained including positive impacts such as soft power. The literature reviews will be undertaken and an analysis plan for the next Committee. There was a discussion over class room sizes, tutor/student ratio and what factors are affecting the number of student places. It was agreed there was a need to find out what domestic students think about the increases in international students and this is a gap in the evidence.

The timeline for completing the Interim Update was discussed. A final draft of the paper would be produced by the end of this week. The next stages of delivery were discussed. The draft paper was reviewed and suggested changes noted.
