### **INTRODUCTION**

- 1 This memo gives guidance on the WR Act 12 (Commencement No. 17, 19, 22, 23 and 24 and Transitional and Transitory Provisions (Modification)) Order 2018<sup>1</sup>. The Order removes the gateway conditions in postcode districts and part-districts in the Live Service area.

- 2 The memo should be read with
  1. ADM [Chapter M3](#) (Claims for UC – Gateway conditions), which gives guidance on claims in the Live Service area **and**
  2. ADM [Chapter M5](#) (Claims for UC – Digital service area), which gives guidance on claims in the UC digital service area (known as Full Service) **and**
  3. ADM [Chapter M6](#) (Effects of transition to UC – Digital service area)
  4. Memo [ADM 1/18](#) (UC: When claims may not be made), which gives guidance on restrictions on new claims in the Live Service area.

### **EXTENSION OF DIGITAL SERVICE CLAIMS**

- 3 Before 1.1.18, claims for UC, new style ESA and new style JSA could be made by



1. single and joint claimants who satisfied the gateway conditions and live in the No. 11 - 15, 17, 19, 21, 23 - 24 and 26 - 27 relevant districts **and**
2. single claimants who satisfied the gateway conditions and live in the No. 29, 31, 37 - 38, 40 - 42, 44 - 46, 48, 53 - 56, 58 - 73, 76 - 77 and 80 relevant districts.

See Memo [ADM 1/18](#) for further guidance on restrictions on claims for UC in the Live Service area which apply from 1.1.18.

**Note:** See ADM M3072 - M3131 for guidance on the gateway conditions, and ADM Chapter [M3 Appendix](#) for details of the relevant districts in the Live Service area.

- 4 Starting from 2.5.18, the requirement to meet the gateway conditions is removed for claims made by people living in specified postcode districts and part-districts included in the relevant districts listed at paragraph 3<sup>1</sup>. These postcodes become UC digital service areas (known as Full Service). See column 1 of the Appendix for details of the postcodes, and column 3 for the date they become digital service areas.

- 5 The guidance in ADM [Chapter M3](#), as far as it relates to claims in the relevant districts listed at column 2 of the Appendix, does **not** apply to claims made by people living in one of the postcodes in column 1, from the date in column 3. The gateway conditions do **not** apply.

## CONDITIONS FOR CLAIMING

- 6 A person is entitled to claim UC, new style ESA and new style JSA where
  1. the claim is made
    - 1.1 on or after the date in column 3 of the Appendix **and**
    - 1.2 for UC, is made in respect of a period beginning on or after that date **and**
  2. the claimant lives in one of the postcodes in column 1 of the Appendix on that date<sup>1</sup>.

- 7 These are claims from people living in a digital service area<sup>1</sup>, where changes to UC legislation as summarised in [M5040](#) apply. See ADM [M5025](#) for guidance on the meaning of a digital service area, and [M5041](#) - [M5042](#) for when the changes apply.



- 8 The guidance in
1. [M5055](#) et seq about UC claims made where the claimant gave incorrect information about whether they live in a relevant district<sup>1</sup> **and**
  2. ADM [Chapters M5](#) (Effects of transition to UC – Digital service area), [S8](#) (JSA Transition) and [V8](#) (ESA Transition) about transition between UC, ESA and JSA<sup>2</sup> **and**
  3. [M5090](#) et seq about claims for HB, IS and TC<sup>3</sup> (see Memos ADM 3/18 and 4/18 about exceptions for HB and temporary accommodation)

applies to claimants living in one of the postcodes in column 1 from the date in column 3 of the Appendix.
