Purpose of the Grant

The purpose of this grant is to provide support to local authorities in England towards expenditure lawfully incurred or to be incurred by them.

This grant is intended to support the projects these local authorities have requested to undertake relating to innovation and reform in children's social care. They may, however, choose how to spend the money in order to best meet local need.

The Children's Social Care Innovation Programme support the development, testing and spreading of more effective ways of supporting children and families who need help from children's social care services.

The Innovation Programme will continue to provide valuable lessons about how to secure better outcomes for our most vulnerable children and how best to structure and resource the work we do with them. They are seeking to inspire whole system change so that by the end of this parliament we achieve:

- Better value for money across children's social care.

Local authorities are undertaking a range of projects to test new ideas and to support other local authorities and children's social care organisations to test and implement new ideas.
