

NOTICE OF ORDER

WILDLIFE AND COUNTRYSIDE ACT 1981

SECTION 53

Hertfordshire County Council
(Kings Langley 47) Modification Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following an earlier inquiry, the Inspector appointed to determine the Order issued a letter in which he proposed to make modifications to the Order as drafted. Following advertisement of those proposals an objections/representation has been received.

The **start date** for the above Order is 4 July 2018.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the modified part of the Order **and** evidence in respect of the unmodified part of the Order.

The effect of the Order, if confirmed without modifications will be to add a footpath commencing from the junction with Kings Langley footpath 17 at TL 0605 0399 and continuing in a generally westerly direction for approximately 375 metres on the southern side of the field north of Lady Meadow, crossing Kings Langley footpath 19 at TL 0568 0398, then continuing in a generally north westerly, north easterly then south easterly direction for approximately 395 metres around the western and northern boundaries of the field to the junction with Kings Langley footpath 19 at TL 0582 0413. Width 2 metres between TL 0605 0399 and TL 0568 0398 and 3 metres between TL 0568 0398 and TL 0582 0413.

The effect of the proposed modifications would be to modify the Order as follows:

- Delete the grid reference specified for point A in the descriptions in Parts I and II of the Order Schedule and insert "*TL0606 0398*".
- Delete the text after the heading "*Width*" within the descriptions for the claimed route in Parts I and II of the Order Schedule and insert "*1.5 metres*".
- Show the revised section on the Order Map and amend the map key accordingly.
- Remove the original section from the Order Map.

Timetable for sending in statements of case and comments

Within 8 weeks of the start date [by 29 August 2018]

The Order Making Authority, the applicant and everyone who has made an objection or representation following the proposed modifications or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after receiving it the Secretary of State will send a full copy to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to everyone who has made an objection or representation following the proposed modifications, the applicant and any other person who has previously written to us in respect of the Order.

Within 14 weeks of the start date [by 10 October 2018]

Everyone who has made an objection or representation following the proposed modifications, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above. In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
