Form ECAA3 is to be used only to apply for an extension of stay in the UK as the dependant of a Turkish national who already has leave to enter or remain as a businessperson or worker under the European Community Association Agreement (ECAA) with Turkey.

However, if the person of whom you are a family member is now applying for an extension of stay under the ECAA with Turkey, you and any other eligible dependants should apply with him or her on form ECAA 1 or ECAA 2.

Form ECAA 3 is only to be used if dependants are having to apply separately for an extension of stay in line with someone who has already been granted leave as a businessperson or worker under the ECAA.

You and any other dependants applying with you must be in the UK to apply.

Qualifying For An Extension Of Stay 2.

For you to qualify for an extension of stay,

- the person of whom you are a family member must have existing leave to enter or remain under the ECAA with Turkey,
- you must be here lawfully, and
- you must be able to prove that you and any other dependants included in the application are related to him or her as claimed.

If you are applying as a dependant of a businessperson, you will need to show that the profits of the business are sufficient to support you and any other dependants.

Who May Apply On This Form? The 3. partner and/or children under 21 of a Turkish businessperson or worker may apply for an extension of stay as dependants.

If no partner is applying and the only dependants wishing to apply on this form are a child or

children under 21, the main applicant in section 1 of the form will be the single or eldest child (if more than one), and any other children under 21 should be included in section 2.

Children aged 21 or over must apply separately.

4. When To Apply

You and any other dependants applying with you should apply before the end of your/their permitted stay in the UK.

Ensuring Your Application Is Complete

Your application will be rejected as invalid if it is incomplete. To avoid that, please ensure that you do the following:

DEFINITIONS

War crimes

Grave breaches of the Geneva Conventions committed during an armed conflict. This includes an internal armed conflict and an international armed conflict. The types of acts that <u>may</u> constitute a war crime include wilful killing, torture, extensive destruction of property not justified by military necessity, unlawful deportation, the intentional targeting of civilians and the taking of hostages.

Crimes against humanity

Acts committed at any time (not just during armed conflict) as part of a widespread or systematic attack, directed against any civilian population with knowledge of the attack. This would include offences such as murder, torture, rape, severe deprivation of liberty in violation of fundamental rules of international law and enforced disappearance of persons.

Genocide

Acts committed with intent to destroy, in whole or in part, a national, ethnical, racial or religious group.

Terrorist activities

Any act committed, or the threat of action, designed to influence a government or intimidate the public and made for the purposes of advancing a political, religious or ideological cause and that involves serious violence against a person; that may endanger another person's life; creates a serious risk to the health or safety of the public; involves serious damage to property; is designed to seriously disrupt or interfere with an electronic system.

Organisations concerned in terrorism

An organisation is concerned in terrorism if it commits or participates in acts of terrorism; prepares for terrorism; promotes or encourages terrorism (including the unlawful glorification of terrorism); or is otherwise concerned in terrorism
