

# Consultation on the Impact Assessment for the Merchant Shipping (Bridge Visibility Regulations) (Small Passenger Ships)

### Purpose of this consultation

1. This consultation concerns the Impact Assessment prepared with respect to proposed changes to the small passenger ship bridge visibility requirements (which are currently implemented via Merchant Shipping (Bridge Visibility) (Small Passenger Ships) Regulations 2005, Statutory Instrument (SI) 2005/2286). These changes are necessary to address:

- A regulatory lacuna that exists for vessels with a registered length of 45m or more.
- A perceived lack of clarity within the definition of enclosed passenger deck and the use of visual aids when determining sight lines.

2. A full regulatory Impact Assessment has now been prepared in respect of these amendments and this consultation aims to seek views on the Impact Assessment only.

## Background

3. The proposed changes will be implemented by a new SI which will repeal and replace the current Regulations. This SI was consulted on between 8 November 2016 and 16 February 2017. Prior to the consultation a Regulatory Triage Assessment was prepared in respect of the Regulations to give an indication of likely impact and confirm that the Regulations were suitable for the 'Fast Track'. The RTA indicated a low likely impact and thus the instrument was able to proceed to consultation before the preparation of a full Impact Assessment.

5. As is required for all domestic measures, and following consultation feedback, an Impact Assessment has been prepared with the support of Dft economists. This

consultation seeks comment on the Impact Assessment before any changes and finalisation.

#### Impact of the changes on the UK Domestic Passenger Ship Industry

6. All the firms currently in operation are compliant with the proposed changes. It is expected that only one firm who may operate vessels in future will need to make changes as a result of the proposals. The impact assessment therefore concludes that the impact is relatively low.
