### Civil contractor designs begin to emerge

In initial reviews with Phase One Main Works Civil Contractors (MWCCs), the panel challenged contractors to develop holistic, landscape-led, robust design approaches, working collaboratively with stakeholders and the local community.

In April 2018, the panel began revisiting the work of MWCCs, starting with Area North contractor Balfour Beatty Vinci. The panel warmly supported the approach presented for the Curzon Street Viaducts, highlighting its potential to create some truly special moments as HS2 arrives into the city of Birmingham.

However, significant challenges remain across Area North, and the panel urged the design team to learn lessons from the Curzon Street Viaducts approach, using it as a benchmark of quality.

Contractor, Eiffage Kier followed in May, describing the next iteration of designs for some of the Area Central structures. Whilst challenges remain, overall the panel applauded the response to the nationally designated Chilterns AONB. The inherently landscape-led approach is producing some powerful and yet sensitively elegant proposals.

The panel will continue revisiting the work of MWCCs over the coming months, including the Skanska Costain Strabag (SCS) consortium in June before Schedule 17 applications are submitted.



# Mentoring with Area North station design teams

Schedule 17 applications for Phase One stations are due to be submitted to local planning authorities in February / March 2019. Making the most of the limited 'time to design' is therefore essential.

In an effort to support the design development process, the Design Panel joined mentoring sessions with the Area North station design teams. This allowed panel members to contribute to the emerging concept designs and provide quick feedback on solutions that the station design teams have developed in response to the challenges of each station.

At this early stage, design work has been focused on understanding the context, and constraints, and how this might influence and shape elements such as concourse options; roof forms; opportunities for activity; and integration with wider regeneration ambitions.

At Curzon Street, a key area will be how the station, and the viaducts that bring HS2 into Birmingham, integrate with the city. Ensuring that these structures work together to create new pieces of city that present platforms for life, activity, and movement will be a key priority. Overall, the panel was encouraged by the station design team's understanding of the complex challenges of each station, highlighting the need for creative and innovative solutions.
