Ken Stimpson Community School	Community School	1262/ (44)	46%	Requires Improvement	High – This is a co-educational school with a sixth form attached for students aged 11-18. It is located 3 miles from the proposed UTC site. The school was judged as 'Requires Improvement' by Ofsted in October 2012. The head teacher of this school is a member of the Peterborough Partnership of Secondary Schools and is supportive of the UTC plans. Therefore, the existing partnership between the school and the lead proposer is likely to reduce any negative impact. The UTC is unlikely to affect the long-term viability of the school.
The Voyager Academy	Academy Sponsor Led	1650/ (15)	42%	Requires Improvement	High – This is a co-educational school for students aged 11–18. The school specialises in digital media and arts, and was judged as 'Requires Improvement' by Ofsted in February 2014. The school works in partnership with The Comberton Academy Trust and the Peterborough Partnership of Secondary Schools. This ongoing relationship as well as significantly different specialisms is likely to mitigate against any negative impact. The UTC is unlikely to affect the long-term viability of the school.
Thomas Deacon Academy	Academy Sponsor Led	2220/ (3)	49%	Require Improvement	Moderate – This co-educational school for students aged 11-18 specialises in maths and science. The school was judged 'Requires Improvement' by Ofsted in July 2013. This school also works in partnership with Peterborough Regional College (the lead sponsor of the UTC) via the Peterborough Partnership of Secondary Schools. The existing partnership should help with joint planning to reduce the impact the UTC might have on the school. The UTC is unlikely to affect the long-term viability of the school.
St John Fisher Catholic High School	Voluntary aided school	753/ (1)	46%	Good	Moderate – This school will aim to attract a particular cohort of students in line with their faith ethos so the impact of the UTC is unlikely to affect the long-term viability of the school.

Jack Hunt School	Foundation school	1785/ (4)	65%	Good	Moderate – This is a co-educational foundation comprehensive school and has a specialist language and sports college that is different to the UTC’s specialisms, therefore the school will aim to attract a particular cohort of pupils. The UTC is unlikely to affect the long-term viability of the school.
Stanground Academy	Academy Sponsor Led	1800/ (50)	62%	Good	Moderate - This is a co-educational 11-18 academy school and is a specialist college for sport.This school is working in partnership with Peterborough Regional College (the lead sponsor of the UTC) via the Peterborough Partnership of Secondary Schools. The existing partnership should help with joint planning to reduce any negative impact.The UTC is unlikely to affect the long-term viability of the school.
Nene Park Academy	Academy Sponsor Led	1100/ (22)	58%	Good	Moderate - Nene Park Academy (formerly Orton Longueville School) is a secondary academy school.The school was renamed in September 2011 when it converted to an academy upon joining Cambridge Meridian Academies Trust (CMAT). The school specialises in business and enterprise, which is different to the UTC’s specialisms. The UTC is unlikely to affect the long-term viability of the school.
Sir Harry Smith Community College	Academy converter	1210/ (1)	61%	Good	Moderate - This school is located 5.1 miles from the proposed UTC site which is above the average distance travelled by secondary school pupils in Peterborough (3.5 miles). Additionally, the college specialises in mathematics and the sciences, which is different to the UTC’s specialisms. The UTC is unlikely to affect the long-term viability of the school.
Ormiston Bushfield Academy	Academy Sponsor Led	950/ (10)	44%	Good	Moderate – This school is located 4.2 miles from the proposed UTC site which is above the average distance travelled by secondary school pupils in Peterborough (3.5 miles). Additionally, this school has specialisms in mathematics, sports and performing arts, which are different to the UTC’s specialisms. The UTC is unlikely to affect the long-term viability of the school.

The college was judged 'Good' by Ofsted in December 2011. In addition, the college is the lead sponsor for the UTC and the specialisms are likely to attract a very different cohort of pupils than those who currently attend the college, a large proportion of whom study at level 1. The UTC is unlikely to affect the long-term viability of the College.
New College Stamford	General Further Education College	1873	573.5	Good	Moderate – The college was judged 'Good' with outstanding features by Ofsted in December 2011, it offers a wide range of courses and apprenticeship courses, and it is 11.4 miles from the proposed UTC site. The UTC is unlikely to affect the long-term viability of the College.
