The Marine Management Organisation (MMO) received a request on 18 July 2017 from DONG Energy for a variation request to remove Condition 14(2)(c) in Deemed Marine Licence (DML) A2 (Project A – Transmission Assets) and DML B2 (Project B – Transmission Assets) within Schedules 9 and 11 respectively of The Hornsea Two Offshore Windfarm Order 2016.
