

We're determined to build long-term relationships with our customers to ensure a smooth customer journey, so we've embarked on an extensive visit plan. You can read about some of our visits below.



Stats and Flag-Ins

Our flag total now stands at 16,531,278 GT, and is the highest it's been for five years.

Recent flag-ins include:

Carisbrooke Shipping's *Xiaoyi C*, a general cargo vessel of 5,629 GT, Anglo International's bulk carrier *Anglo Alexandria* 63,940 **GT**, **and** Nordic American Offshore (NAO) vessels *Horizon*, *Galaxy* and *Guardian*, *a* combined total of 10,545 GT.

Red Funnel's latest in the great tradition of Isle of Wight passenger ferries, *Red Jet 7*, also joined the Flag in July, as did Forth Ports tug *Craigleith* and the *Ailsa*, a Floating Production, Storage and Offloading System**s** (FSO), of 66,654 GT operated by Maersk North Sea UK Limited jointly with BRITOIL limited and JX NIPPON Exploration and Production (UK) Limited.

We also welcomed two commercial yachts— *Earl of Pembroke* and *Shenandoah of Sark*.

Sentinel Marine's 2,173 GT *Bailey Sentinel,* (pictured) is the latest in Offshore Support Vessels to join the Flag.

Green indicators all in the International Chamber of Shipping Industry Flag State performance table

We're one of only 18 registries of the 119 assessed to be given green performance indicators in every category of the Flag State table.

The table provides an indication of the performance of flag states worldwide, analysing how administrations deliver against activities such as port state control, ratification of international maritime conventions and attendance at IMO meetings.

Up to 5th on Paris MoU White list

Paris MoU



Consistent high performance has seen the UKSR move up to 5th place in the Paris MoU flag state performance table for 2017 effective from 1 July. The table is based on the total number of inspections and detentions over a three-year rolling period for flags with at least thirty inspections in the period.

The Paris MoU committee approved the 2017 inspection results at its meeting in May for flags and Recognised Organisations (RO). The White, Grey and Black Lists show flag state performance, from flags with a high performance to flags with a poor performance that are considered high or very high risk.

Doug Barrow said, "We are absolutely delighted by this recognition of the high levels of service we provide to our owners and operators on a 24/7 basis. The Paris MoU is an internationally recognised standard, and this endorses us as a quality flag for quality owners".



She enjoyed responding to seafaring questions and discussed the benefits of the UK Flag with brokers, yacht managers and industry influencers. "We're looking forward to attending as an exhibitor next year," said Sarah.

The LYS also attended the Palma Yacht Show, as it features several UK-flagged yachts over 24m, including *Leopard*, *Shenandoah* and *Nostromo*.

Meanwhile sharing best practice and knowledge were the main themes at the 30th Red Ensign Group (REG) Conference in <u>Guernsey</u>. The conference was co-chaired by Sir Alan Massey, CEO of the Maritime & Coastguard Agency and Chad Murray of <u>Guernsey</u>. Priority topics included: sharing surveyor resources, a review of the Red Ensign Group Yacht Code (which comes into force next year) and the IMO III Code audit (2020).

"We are very proud to be part of the REG and to be celebrating this 30th anniversary," said Doug Barrow.

Merchant Navy Day

On Monday 3 September 2018, Merchant Navy Day, the nation showed appreciation for our Merchant Navy seafarers past, present and future. People were encouraged as part of the Seafarers UK campaign to fly a Red Ensign ashore.

Doug Barrow, Director of UKSR commented, "Having sailed under the Red Ensign for seven years, it has a place in my heart and I now have the honour to lead the UK Ship Register to increase the number of ships at sea flying the Red Ensign.

Acknowledging the sacrifice made by so many merchant seafarers over the years, both in times of war and peace, the Red Duster flew over 800 locations across the country, reminding the nation that we are an island and over 90% of global trade, comes by sea.

Merchant Navy Day provided the opportunity to celebrate, across the

nation, what the Merchant Navy has meant to this country over many years. We saluted those who gave their lives, but also acknowledged the many thousands of British



seafarers at sea today manning ships around the world".

The campaign raised awareness of our island nation's dependence on seafarers and shipping and saw the British Merchant Navy's official flag flying atop civic and historic buildings across the UK and in prominent public locations. For more information, go to

Introducing our team

Customer Account Managers (CAMs) Suzanne Landolfi and Celia Ghoshroy have worked in shipping for most of their careers, with the last ten years spent with the MCA. She then went on to work with Regent and Silver Sea as Guest Relations Manager, where she dealt with everything from guest complaints, customs and immigration enquiries, medivacs and embarkation to liaising with port agents and chasing lost luggage around the globe!

"One of the best aspects of the job was getting to meet lots of guests through hosting tables and organising cocktail parties" Celia explains.

Joining the MCA as Customer Insight Co-ordinator, she learned how to market campaigns to suit customer needs and got to know the varied nature of the MCA and customers of the UK Ship Register.

Suzanne (pictured bottom right) began her career as a Communications Officer in Barry, South Wales for the Natural Environment Research Council. She worked with the *RRS Discovery, Challenger* and *Charles Darwin*, dealing with the operational requirements of the ships and the scientists.

A move to Southampton saw Suzanne become the first ever female port agent, boarding all different ship types including tankers, bulk carriers, container and ROROs, in all ports from Portland to Shoreham. She then joined P&O Nedlloyd as the team leader of the American Imports Customer Service Team, working with blue chip customers.

Almost ten years ago, Suzanne joined the MCA as team leader of the Certificate of Equivalent Competency (CEC) team, and then spent five years in Inspection Branch, dealing with Port State Control and giving policy advice and technical support before joining the UKSR and becoming a CAM.

"Using my experience, I aim to do the best for our customers and the UK flag", says Suzanne. "I understand and can help our customers to overcome any hurdles and in doing so make sure that our customers receive the very best levels of customer service."
