NOTE

1. The Code of Practice adopted by the Committee provides that:

“All Committee members should declare any personal or business interest which may, or may be perceived (by a reasonable member of the public) to influence their judgement. This should include, as a minimum, personal direct and indirect pecuniary interests, and should normally also include, such interests of close family members and of people living in the e- same household. The register of interests should be kept up-to-date and should be open to the public.

A declaration of any interest should also be made at any Committee meeting if it relates specifically to a particular issue under consideration, for recording in the minutes (whether or not the Committee member also withdraws from the meeting).”
