The Armed Forces Covenant

**An Enduring Covenant Between
The People of the United Kingdom
Her Majesty's Government
and –**

**All those who serve or have served in the Armed Forces of the Crown
And their Families**

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty. Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

Section 1: Principles Of The Armed Forces Covenant

We **Catalyst Defence Services Ltd** will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:

no member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen in some circumstances special treatment may be appropriate especially for the injured or bereaved.

Section 2: Demonstrating our Commitment

2.1 At **Catalyst Defence Services Ltd**, we support innovations that strengthen UK security. We deliver solutions to defence and security problems to keep our nation at the forefront of modern capability. Catalyst recognises the value serving personnel, reservists, veterans and military families bring to our business. We will seek to uphold the principles of the Armed Forces Covenant, by:

- *Promoting the fact that Catalyst are an armed forces-friendly organisation by publicising our Covenant on our website and displaying the Covenant logo;*
- *Recognising and valuing the skills and experience Service Leavers and Veterans offer business and seek opportunities to support the employment of veterans young and old by advertising in military welfare community areas, through the Career Transition Partnership and via social media.*
- *Endeavour to provide opportunities to support the employment of Service spouses and partners in order they not disadvantaged.*
- *Adopting a sympathetic and flexible approach for request for leave for Service spouses and partners before, during and after a partner's deployment;*

- *Encourage employees to volunteer and raise funds for Armed Forces Charities.*
