- (a) **Volunteer Bat Roost Visitor class licences** - New applicants for Volunteer Bat Roost Visitor class licences must have their application forms endorsed by a registered and licensed trainer. Registered Volunteer Bat Roost Visitor class licence users must **also** be registered as Natural England volunteers. The purpose of a licensed trainer is to train registered trainees for a Volunteer Bat Roost Visitor licence.

It is a condition of the Volunteer Bat Roost Visitor licences (Level 1 WML-CL15 and Level 2 WML-CL16) that each registered Volunteer Bat Roost Visitor provides Natural England with a report by 31st May each year. This must state whether they wish to remain registered to use the licence and confirm that Bat Roost Visit Report Forms were submitted to the Bat Advice Contractor for each site where the licence was used.

5. Volunteer Bat Roost Visitor Class Licences

The Volunteer Bat Roost Visitor class licences are issued solely for the purpose of carrying out official visits as part of Natural England's Bat Advice service. All those wishing to be registered to use the Volunteer Bat Roost Visitor licence must be registered as volunteers with Natural England as a condition of the licence (this includes trainees). Please contact batvolunteers@naturalengland.org.uk mailbox for assistance in registration.

Volunteer Bat Roost Visitors may be required to visit a property where bats have been discovered in order to advise the property owner on the implications of the presence of the bats and to encourage a favourable outcome for the conservation of them. A licence is required to carry out this work which may also require the Volunteer Bat Roost Visitor to examine or handle bats in their roost. A Volunteer Bat Roost Visitor licence may only be relied upon when undertaking official duties as a Volunteer Bat Roost Visitor, under Natural England's Bat Advice Service, or when training unlicensed Volunteer Bat Roost Visitor workers. This type of licence is issued for conservation purposes and there is no specification for scientific recording: if you wish to apply for a licence for surveying and monitoring, **please complete section 6** of this form.

6. Class Licences for Surveying

These class licences should be used to collect data to increase scientific knowledge. Registered persons can be individuals who undertake bat survey and monitoring work in a voluntary or professional capacity. Registered persons will be required to complete an annual report form to provide details of the work carried out under licence.

If you are applying for a class licence to carry out a survey, visits need to be regulated to limit disturbance and therefore you are encouraged to liaise with appropriate local bat groups or licensees.

Please specify which level of class survey licence you are applying for (tick one box unless Level 3 & Level 4):

- Level 1 (WML-CL17)** – This class licence permits the disturbance of bats by observation only (including the use of artificial light, in the form of torches but not endoscopes). Disturbance of hibernating bats is not permitted.
- Level 2 (WML-CL18)** – This class licence permits the disturbance of bats using artificial light (e.g. torches) and endoscopes, and the taking/capture of bats by hand and use of static hand-held nets. Disturbance, but not the taking, of hibernating bats is permitted.
- Level 3 (WML-CL19)** – This class licence permits the disturbance of bats using artificial light (e.g. torches) and endoscopes, and the taking/capture of bats by hand, static hand-held nets, mist nets and acoustic lures. Disturbance, but not the taking, of hibernating bats is permitted.
- Level 4 (WML-CL20)** – This class licence permits the disturbance of bats using artificial light (e.g. torches) and endoscopes, and the taking/capture of bats by hand, static hand-held nets, harp traps and acoustic lures. Disturbance, but not the taking, of hibernating bats is permitted.

Please Note: Survey class licences Levels 3 and 4 issued to use **harp traps or mist nets (with acoustic lures) for surveying** only permit these activities to be carried out for a maximum of 3 days at any one site and only where surveys are required to inform impact assessments of development proposals. If you have a requirement to use either technique for a longer time period or for a different purpose you will need to complete a separate project plan and apply for an individual licence application. Any licence application for harp traps or mist nets and acoustic lures must be supported by one or two references from suitably experienced person(s) who hold a licence to use these methods. Acoustic lures do not have to be employed each time a harp trap or mist net is used. It is up to the registered person to determine what methods are appropriate and to utilise this method responsibly. Accredited agents cannot undertake harp trapping, mist netting or use lures under the class survey licences – only the registered person is licensed to undertake these activities or to directly supervise an assistant.

Please note: **photographing** bats is permitted under all levels of the bat class licences, provided that no additional disturbance is caused. If additional disturbance would be caused, then a specific project application would be required (using form WML-A34).

Please note: **handling hibernating bats** is not permitted under any of the bat survey class licences. If handling hibernating bats (for example to read rings) is considered to be a necessary element of your survey/monitoring/research, a separate project plan will need to be made (using form WML-A34).

Please note: should you wish to check **bat boxes** and it is likely that you will handle bats whilst doing so a Level 2 class survey licence is required. A Level 1 class survey licence is only applicable where bats will not be handled.

This will include, but is not limited to assessing your application, issuing a licence if applicable, monitoring compliance with licence conditions and collating licence returns and reports. The personal information we will process will include, but is not limited to your name and contact details, customer type and reasons for wanting a licence. Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the data controller. That task is to conduct the licensing functions as delegated by Defra to Natural England under Part 8 Agreement under section 78 of the Natural Environment and Rural Communities Act 2006.

The processing by us of personal data relating to wildlife-related or animal welfare offences or related security measures is carried out only under official authority. This information is used in assessing an application as it is a material fact. Important Advice:

- **If your application is made under the Wildlife and Countryside Act 1981 (as amended) or the Conservation of Habitats and Species Regulations 2017, any person who in order to obtain a licence knowingly or recklessly makes a statement or representation, or furnishes a document or information which is false in a material particular, shall be guilty of an offence and may be liable to criminal prosecution. Any person found guilty of such an offence is liable, on summary conviction, to imprisonment for a term not exceeding six months or to a fine not exceeding level 5 on the standard scale, or to both. Regarding other wildlife legislation, we will look to provisions in the Fraud Act 2006 (as amended) in respect of applicants making any false representations.**
- **Natural England or the Secretary of State can modify or revoke at any time any licence that is issued, but this will not be done unless there is good reason for doing so. Any licence that is issued is likely to be revoked immediately if it is discovered that false information has been provided that resulted in the issue of a licence.**
