The Armed Forces Covenant

An Enduring Covenant Between

The People of the United Kingdom Her Majesty's Government

and -

All those who serve or have served in the Armed Forces of the Crown

And their Families

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty.

Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

Section 1: Principles Of The Armed Forces Covenant

- 1.1 We Scorpion Protection International Ltd will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:
 - no member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen
 - in some circumstances special treatment may be appropriate especially for the injured or bereaved.

Section 2: Demonstrating our Commitment

- 2.1 Scorpion Protection International Ltd recognises the value serving personnel, reservists, veterans and military families bring to our business. We will seek to uphold the principles of the Armed Forces Covenant, by:
 - promoting the fact that we are an armed forces-friendly organisation; by openly inviting veterans and their spouses to interview & assessment days
 - seeking to support the employment of veterans young and old and working with veterans' charities in order to establish a tailored employment pathway for Service Leavers; by encouraging discounted training and by making the extra effort to resettle veterans into the private security industry, utilising their skills and discipline and further enhancing them where possible for the civilian transition.
 - striving to support the employment of Service spouses and partners; by ensuring there are adequate course spaces and advertisements encouraging them to attend training and our interview sessions
 - endeavouring to offer a degree of flexibility in granting leave for Service spouses and partners before, during and after a partner's deployment; we make every effort and encourage time off prior to deployment and make suitable arrangements wherever possible to accommodate.

- offering support to our local cadet units, either in our local community or in local schools, where possible; offering our time where appropriate to assist with specialist sessions and training helping young people to participate in otherwise difficult circumstances.
- offering a discount to members of the Armed Forces Community; for all of our training both nationally and internationally.
- 2.2 We will publicise these commitments through our literature and/or on our website, setting out how we will seek to honour them and inviting feedback from the Service community and our customers on how we are doing.
