"Can you help me with information about Charles Hobart Ellis?. In the 1920s and later he was British Vice Consul in Berlin. Do you have any information in your archives about him? I am sure he was in contact with SIS and MI6"

I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has now been completed within the Ministry of Defence and based on the on the information you provided on Charles Hobart Ellis and I can confirm that no information in scope of your request is held.


