The Regulated Community is reminded to check this amendment against any applicable AAMC, Waivers or Exemptions to ensure their ongoing validity.
RA 1006 currently enables a TAA to create 'Appointed Level J and K' positions within DE&S. Appointed Level J and K roles exercise only Continuing Airworthiness authority so it is anomalous that they can be created by TAAs who themselves have no accountability for Continuing Airworthiness. Every Level J/K appointee must be clear that they are accountable to the Aviation Duty Holder (ADH), who is accountable for Continuing Airworthiness as required by RA 1020 – Roles and Responsibilities: ADH and ADH-Facing Organizations. In response to a RFC, it is proposed that Appointed Level J and K positions required within DE&S should be authorized by a Senior Duty Holder Chief Air Engineer (CAE) or Operating Duty Holder CAE (if delegated), which is the same requirement for 'Appointed Level J and K' roles within an ADH's Area of Responsibility.
