## Amendments to the Deemed Marine Licence in The Triton Knoll Offshore Wind Farm Order 2013

Dear Ms Opel

As recently discussed during our telephone conference meeting on 20 September 2018, I am writing to request an amendment to the deemed Marine Licence (dML) which was granted as part of The Triton Knoll Offshore Wind Farm Order 2013 ("the 2013 Order"). The approved dML was included at Schedule 2 of the Order.

The dML requires variation to:

- (a) Update the wording of the dML to reflect the recent non-material changes made to the 2013 Order following BEIS's approval of The Triton Knoll Offshore Wind Farm (Amendment) Order 2018. This will ensure there is consistency between the parameters of the project's development consent and the parameters of the project's dML; and
- (b) Amend the wording in dML Condition 9 (1) to reflect the wording already set out in the equivalent Condition 7 of the dML for The Triton Knoll Electrical System Order 2016 ("the TKES Order") by inserting into Condition 9(1) the words shown *underlined and in italics* below:

"The licensed marine activities <u>or any part of those activities</u> must not be commenced until the following <u>(as far as relevant to that part)</u> have been submitted to and approved in writing by the MMO"

This will allow for staggered submissions of the various work packages for the licensed activities in the same way as it has been agreed that the TKES Order allows for staggered submissions.
