

# **NOTICE OF ORDER**

## **WILDLIFE AND COUNTRYSIDE ACT 1981**

### **SECTION 53**

Suffolk County Council

(Thingoe Rural District Definitive Map and Statement) (Parishes of Chevington, Horringer and Ickworth) Modification Order 2017

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **2 January 2019**

Consideration of the Order will take the form of a public local inquiry.

The Inquiry will be held at **The Erskine Centre, Chevington Road, Chedburgh IP29 4UL** on **Wednesday 5 June 2019** at **10.00am**.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding a public footpath from the south-western end of Horringer Footpath 6 at Ordnance Survey Grid Reference 58233,26075 through Ickworth Park to the C661 in Chevington at Ordnance Survey Grid Reference 57994,25947, as shown on the order plan.

**As the Authority has indicated that they will not be supporting the Order at the Inquiry, the case for the Order will be submitted by the applicant, John Andrews. He will be expected to adhere to the following timetable as if he were the Authority.**

#### **Timetable for sending in statements of case and proofs of evidence**

**Within 8 weeks of the start date by [by 27 February 2019]**

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation and the applicant and any other person who has written to us in respect of the Order.

### **Within 14 weeks of the start date [by 10 April 2019]**

Everyone who has made an objection or representation and anyone who wishes to give evidence at the Inquiry must ensure their statement of case<sup>1</sup> is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

### **4 weeks before the date of the inquiry [by 8 May 2019]**

The Authority, everyone who has made an objection or representation, the applicant (if applicable) and anyone who wishes to give evidence at the Inquiry must ensure their proof of evidence (together with any summary) is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of:

- i) the Authority's proof of evidence to everyone who has made an objection or representation, the applicant and anyone who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence);
- ii) the applicant's proof of evidence to the Authority, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence); and
- iii) all other proofs of evidence to the Authority, the applicant, everyone who has made an objection or representation and anyone else who has submitted a statement of case (excluding copies of any supporting documents – although none should be submitted with a proof of evidence).

**All parties must keep to the timetable set out above and ensure that statements of case and proofs of evidence are received by the Secretary of State on time. Late documents will be returned.**

This Order is made by Suffolk County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act"), because it appears to that authority that the Definitive Map and Statement for the former Rural District of Thingoe in the former Administrative County of West Suffolk require modification in consequence of the occurrence of an event specified in section 53(3)(c)(i) namely, the discovery of evidence which shows that footpaths which are not shown in the map and statement subsist or are reasonably alleged to subsist.

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Suffolk County Council hereby Order that:


1. For the purpose of this Order the relevant date is 1 February 2017.
2. The Definitive Map and Statement for the former Rural District of Thingoe in the former Administrative County of West Suffolk shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Suffolk County Council (Thingoe Rural District Definitive Map and Statement)(Parishes of Chevington, Horringer and Ickworth) Modification order 2017.

## SCHEDULE

### Part I: Modification of Definitive Map

#### Description of footpaths to be added

There shall be added to the Definitive Map for the former Rural District of Thingoe in the parishes of Chevington, Horringer and Ickworth a footpath from a point at Ordnance Survey grid reference 58233,26075 (point A) to a point at Ordnance Survey grid reference 57994,25947 (point M) as shown on the order map.

### Part II: Modification of Definitive Statement

#### Particulars of footpaths to be added

There shall be added to the Definitive Statement for the former Rural District of Thingoe the following particulars:

#### **Horringer FP6**

Add to the end of existing definitive statement:

; continuing for 245 metres to the parish boundary and Ickworth FP1 at Ordnance Survey Grid Reference 58210,26068 (point B).

#### **Ickworth FP1**

Commencing at a junction with Horringer FP6 at Ordnance Survey Grid Reference (OSGR) 58210,26068 (point B) and progressing in a generally west-south-westerly direction for 490 metres then entering a narrow tree belt and crossing the River Linnet at OSGR 58164,26049 (point C); continuing for 559 metres across a field to the edge of a small wood at OSGR 58127,26007 (point D); continuing through the wood for 71 metres to OSGR 58122,26002 (point E); continuing for 163 metres across a field to the south eastern corner of Lownde Wood at OSGR 58111,25990 (point F); passing through the wood for 42 metres to OSGR 58108, 25987 (point G) then changing to a generally west-south-westerly direction and continuing for 356 metres on the southern side of Lownde Wood to a junction with Chevington FP18 at OSGR 58074,25979 (point H).

#### Width:

Between OSGR 58210,26068 (point B) and OSGR 58164,26049 (point C) varying between a minimum of 2 metres and a maximum of 4 metres as shown on OS 1<sup>st</sup> edition County Series.

Between OSGR 58164,26049 (point C) and OSGR 58074,25979 (point H) varying between a minimum of 1 metre and a maximum of 2 metres as shown on OS 1<sup>st</sup> edition County Series.

NB. Widths based on measurements taken from Ordnance Survey County Series 1<sup>st</sup> edition 1/2500 scale mapping, dated 1885, sheets 44/13, 53/4 and 54/1, as the nearest contemporary source to the Inclosure/Tithe maps.

### **Chevington FP18**

Commencing at a junction with Ickworth FP1 at Ordnance Survey Grid Reference (OSGR) 58074,25979 (point H) and progressing in a generally west-south-westerly direction for 107 metres to OSGR 58063, 25975 (point I); crossing a boundary then changing to a generally west-north-westerly direction and continuing for 60 metres on the southern side of a boundary to another boundary at OSGR 58057,25976 (point J); crossing the boundary and changing to a generally south-westerly direction for 396 metres on the north-western side of a boundary to OSGR 58029,25949 (point K); changing to a north westerly direction and continuing for 98 metres on the north eastern side of a boundary to OSGR 58023,25956 (point L); changing to a generally west-south-westerly direction for 306 metres on the northern side of a boundary to a junction with the C661 at OSGR 57994,25947 (point M).

#### **Width:**

Between OSGR 58074,25979 (point H) and OSGR 58057,25976 (point J) varying between a minimum of 1 metre and a maximum of 2 metres as shown on OS 1<sup>st</sup> edition County Series.

Between OSGR 58057,25976 (point J) and OSGR 58029,25949 (point K) varying between a minimum of 2 metres and a maximum of 3 metres as shown on OS 1<sup>st</sup> edition County Series.

Between OSGR 58029,25949 (point K) and OSGR 58023,25956 (point L) varying between a minimum of 1 metre and a maximum of 2 metres as shown on OS 1<sup>st</sup> edition County Series.


Between OSGR 58023,25956 (point L) and OSGR 57994,25947 (point M) increasing from 1 metre to 4 metres as shown on OS 1<sup>st</sup> edition County Series.

MAP NOT TO ORIGINAL SCALE


# PROPOSED PUBLIC FOOTPATHS IN CHEVINGTON, HORRINGER AND ICKWORTH
