Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed. The nature of the work that IIC and previously Ramtech have done for us is: SNC chart compilation
Leisure chart compilation
ENC creation
Photoplot capture from imagery.

All work is verified, and quality checked at UKHO. This year IIC have started to work on Notice to Mariners drafting and subsequent chart base updating.

3. And was the type of work involved ever carried out by UKHO staff.

All types of work outsourced to third party contractors also is or can be undertaken by staff at UKHO. Outsourcing some of our activity serves 2 main purposes - it gives us greater capacity to produce more products with a flexible resource; and it frees staff from some compilation tasks to take on more complex tasks and work that moves us forward, towards our corporate vision.
