I am treating your correspondence as a request for information under the Freedom of Information Act 2000.

A search for the information has now been completed within the Ministry of Defence, and I can confirm that information in scope of your request is held and can be found below.

The information requested in question 1 is as follows:

The information requested in question 2 is as follows:

Under Section 16 of the Act (Advice and Assistance) you may find it helpful to note that for question 2, due to the dates of the purchases, some of the contract files had been archived and then destroyed. Therefore, it was not possible to confirm what quantity was purchased specifically as Urgent Operational Requirements. It was also not possible to distinguish L105A1 from L105A2 purchases (i.e. P226) and, therefore, 2.a. includes a combined total.
