Schedule 1

Special 'Exempt' Market

Schedule of Conditions for the Sale of Cattle to Restricted Destinations without the requirement for Pre-Movement Testing.

- 1) The 'exempt' market will allow sales of any cattle which are not subject to DCO standstill requirements, including those that are eligible for pre-movement testing, without such testing. All cattle entering the exempt market are subject to the restriction that their onward consignment must be:
 - direct to a slaughterhouse
 - direct to an Approved Finishing Unit (AFU)
 - direct to an Exempt Finishing Unit (EFU)
 - back to their premises of origin (except where these are subject to four yearly testing).
- 2) It is an offence for any person to move a bovine animal from an exempt market to anywhere other than a permitted destination.
- 3) The licensed premises must be capable of accommodating the maximum number of cattle anticipated.
- 4) Clear testing animals from TB restricted herds cannot enter exempt markets. These must go direct to slaughter, a TB collection centre or to AFUs. They can be sold through a TB restricted market but an exempt market and restricted market cannot be held at the same time although they may be part of the same occasion.
- 5) Any animals showing clinical signs of TB in a market are considered 'unfit' and, as such, must be immediately isolated and reported to the Veterinary Head of Field Delivery (VHoFD).
- 6) Other normal unrestricted 'green' markets may be held on the same site as an exempt market but there must be clear separation (either physical or by time) between the animals in the exempt market section and other animals.
- 7) The market operator must notify APHA a minimum of five working days in advance of each market to be held.

Schedule 2

Slaughter Gathering for the Sale of TB Restricted Cattle

Schedule of conditions for the Collection or Sale of Cattle from Herds under TB Movement Restrictions for onward consignment to a slaughterhouse.

- 1) These dedicated 'red' gatherings must have been licensed under the Animal Gathering Orders (as amended) Article 11 as dedicated slaughter sales or collections for the onward consignment of all the animals direct to a slaughterhouse within GB and can either be:
 - a) gatherings for the sale of cattle for onward consignment to a slaughterhouse that are additionally approved to include cattle which, due to TB movement restrictions, cannot enter a regular market
 - b) collections that have been approved for the collection of slaughter stock which have places at an abattoir in GB already booked that are additionally approved to include cattle which, due to TB movement restrictions, cannot enter a regular collection. They do not include a sale.
- 2) Cattle moving through these gatherings should be:
 - Unrestricted cattle
 - Cattle from TB restricted premises; all must have tested clear within the previous 90 days and which are not classified as reactors, unresolved IRs or DCs. Resolved IRs from the High Risk Area, Edge Area, and breakdown herds in the Low Risk Area, remain restricted for life but are eligible to move through a slaughter gathering. Cattle moving from non-grazing AFUs to slaughter gatherings in England do not require to be tested in the previous 90 days
 - Untested calves under 42 days old may be accepted providing they have not been classified as reactors, unresolved IRs or DCs. These calves should not be gathered for individual sale.

Additionally, dedicated slaughter sales can accept cattle eligible for pre-movement tuberculin testing (PrMT) from non-restricted premises, thereby acting as intermediate destinations for cattle that are being moved to slaughter without pre-movement tested cattle and PrMT-exempt cattle from non-restricted premises can also enter these sales en route to slaughter. Therefore, a 'dedicated, TB approved, slaughter gathering' ('red market') can involve up to five different categories of cattle:

- Clear-testing cattle from TB-restricted premises (which may include resolved IRs from the High Risk and Edge Areas and breakdown herds in the Low Risk Area)
 - Untested cattle from non-grazing AFUs (only applies for slaughter gatherings in England)
 - PrMT-eligible (but untested) cattle from non-restricted premises
 - Pre-movement tested cattle from non-restricted premises
 - Untested cattle from PrMT-exempt, non-restricted premises.
- 3) Market operators must comply with the requirements of the following legislation and subsequent amendments or changes:

- 4) The licensed premises must be capable of accommodating the maximum number of cattle anticipated.
- 5) The market operator must ensure that additional conditions for approved TB slaughter gatherings (e.g. movement licences, use of TB-approved disinfectants, etc.) are met.
- 6) Any animals showing clinical signs of TB in a market are considered 'unfit' and, as such, must be immediately isolated and reported to the VHoFD.
- 7) The market operator must notify APHA a minimum of five working days in advance of each gathering to be held.

- 8) Gatherings for calves can be approved within a red market BUT the additional requirements are as follows:
- Calves must not be consigned to the gathering if 42 days of age or over unless they have reacted negatively to a tuberculin test within the previous 90 days
 - Market staff must ensure that all passports are checked prior to unloading any calves into the gathering.
 - Calves should only be gathered from restricted premises for onward consignment to a pre-booked abattoir and the licence will state the abattoir in Part 2
 - Movement of calves must comply with all welfare legislation
 - Market operators must ensure that the number of pre-booked slaughterhouse places available is sufficient for the number of calves entered for the gathering
 - If insufficient places are available at the slaughterhouse, the market operator must immediately notify the farmer(s) concerned and the licensing APHA office(s) prior to the date of the gathering and identify which calves will not be consigned to that gathering
 - All calves must be loaded for onward consignment to the destination abattoir (with the updated licence as required) within four hours of the sale of the last calf
 - As they will not be individually sold, in practice they should be moved off the premises as soon as possible and this should be considered to be within four hours of the arrival of the last calf.
- 9) The time spent on the market premises must also be considered when ensuring compliance with requirements of the Welfare of Animals (Transport) (England) Order 2006 and/or the Welfare of Animals (Transport) (Wales) Order 2007.

Vendors, hauliers and market operators must comply with the requirements of the Welfare of Animals (Transport) (England) Order 2006 and/or the Welfare of Animals (Transport) (Wales) Order 2007. - 10) The auctioneer must collate a schedule, broken down by holding of origin, of all the TB restricted cattle sold. The schedule must give the:
- County Parish Holding (CPH) number and name of the vendor
 - official identification of the animal
 - name and CPH of the buyer
 - slaughterhouse of destination.
- This schedule must be sent electronically to APHA (TB.Advice@apha.gov.uk) within 24 hours of the end of the sale.

Schedule 3

Approved Dedicated Sale for TB Restricted Cattle

Schedule of conditions for the Sale of Clear Testing Cattle from Herds under TB Movement Restrictions to Destinations approved using a Veterinary Risk Assessment.

- 1) The Sale for TB restricted cattle ('orange' market) will allow sales of any cattle which are not subject to DCO standstill requirements. The farmer **must** be responsible for ensuring no cattle have moved onto the premises within the previous seven days under any general or individual licence conditions. A dedicated sale will be approved for TB restricted cattle only. Cattle from unrestricted farms and species of livestock other than cattle will not be permitted in the sale.
- 2) All cattle entering the restricted market are subject to the restriction that their onward consignment must be:
 - direct to a slaughterhouse
 - direct to an AFU (in England only) or
 - for a herd dispersal sale only - direct to the premises of origin under the conditions of a Licence (TB16c) authorising the movement (in England only).
- 3) Herd dispersal sales, where the herd is under TB restrictions, may be held in a dedicated sale for TB restricted cattle using the permit to disallow the six day standstill in addition to the conditions for the dedicated sale.
- 4) It is an offence for any person to move a bovine animal from a restricted market to anywhere other than a permitted destination. They are **not** eligible to go to an **exempt** finishing unit.
- 5) Any purchaser must provide evidence to the market that they fulfil the criteria to move cattle from the market, either by presenting their approval as an AFU or to remove them **directly** to slaughter.
- 6) The conditions for approval for a dedicated sale for TB restricted cattle are additional to the conditions for the Animal Gathering Licence and do not replace them.
- 7) Market operators must comply with the requirements of the following legislation and subsequent amendments or changes:
 - i. [The Animal Gatherings \(England\) Order 2010](#)
 - ii. [The Welfare of Animals \(Transport\) \(England\) Order 2006](#)
 - iii. [The Disease Control \(England\) Order 2003](#)
 - iv. [The Transport of Animals \(C&D\) \(England\) \(No 3\) Order 2003](#)
 - v. The Welfare of Animals in Markets Orders 1990 as amended by [The Welfare of Animals at Markets \(Amendment\) Order 1993](#)
 - vi. Any relevant disease control zones.
- 8) The licensed premises must be capable of accommodating the maximum number of cattle anticipated.
- 9) This type of market is for clear testing animals from TB restricted herds and not for unrestricted cattle. All cattle must have been clear tested for TB in the previous 90 days. Resolved IRs from the High Risk Area, Edge Area, and breakdown herds in the Low Risk Area, remain restricted for life but are eligible to move through a dedicated sale for TB restricted cattle.
- 10) There must be clear separation by time between the animals in the restricted market section and other animals. Other gatherings will not be permitted on that premises at the same time as the TB restricted sale and all cattle moving under the licence for TB restricted cattle must have left the site before any other gathering is held. Any market areas to be used by non-restricted cattle as part of the same occasion must have been cleansed and disinfected as per the TB Order prior to these areas being used by unrestricted cattle.
- 11) Any animals showing clinical signs of TB in a market are considered 'unfit' and, as such, must be immediately isolated and reported to the VHoFD.
- 12) The market operator must notify APHA a minimum of five working days in advance of each sale to be held.
- 13) Animals must only be accepted for sale and moved on to the sale premises upon presentation of a valid licence for that movement and are subject to the conditions of that licence and can only move from the market upon presentation of the approval notice for an AFU or details of a slaughterhouse. Movements out of the market will be direct to the destination and will be subject to the conditions of the Licence (TB16b) and the purchaser/keeper will be responsible for compliance with the conditions of the licence.
- 14) The auctioneer must complete the licence with the details of the destination of the animals and the name and address of the purchaser/keeper, copying the licence as necessary if a batch of cattle has multiple destinations.
- 15) The auctioneer must collate a schedule, broken down by holding of origin, of all the TB restricted cattle sold. The schedule must give the:
 - CPH number and name of the vendor
 - official identification of the animal
 - name and CPH of the buyer
 - AFU or slaughterhouse of destination.This schedule must be sent electronically to APHA (TB.Advice@apha.gov.uk) within 24 hours of the end of the sale.
- 16) Any unsold animals must be reported to APHA and the Local Authority and a contingency plan for dealing with these animals held and carried out prior to any continuation of further sales within the same occasion.
