We are looking for Subject Matter Experts in health and safety with extensive experience of the successful provision of NEBOSH training, the scope shall specifically include (but will not be limited to):

NEBOSH National General Certificate in Occupational Health and Safety NEBOSH National Certificate in Construction Health and Safety NEBOSH National General Certificate in Fire Safety and Risk Management

Note Sellafield is looking to be able to book candidate places onto NEBOSH training courses that may be with candidates from other employers or industries. In the future we may look to have block-booked courses run specifically for Sellafield Ltd through this contract, but for the purposes of this competition we are looking at the pricing and provision of individual places.

The preferred location for the training provision is West Cumbria.

Details of the relevant experience and qualifications of the tutors proposed to deliver the training. **No more than 1 side A4**

3. Typical pass rate of students over the last three years and details of the arrangements for resits. Specify how many of the passes were from resits. **No more than 1 side A4**

4. A proposed maximum target cost for one place on each course with an overview of what is included in the price.
