- 23/07/14 He stated that this year's report would not be significantly different from what had been published previously, but more a refresh. He reported that an internal workshop had taken place and the key changes identified were to the non-financial risks section of the report, liability based risks and income based risks.
- 24/07/14 The key strategic non-financial risk which had been identified for inclusion in this year's report centred on providers working in a more political environment with a higher profile in the media, as well as increased political interest.
- On liability based risks the key risk concerned providers taking on new debt and whether Boards understand the complexities of the financial transactions being entered into. The Deputy Director Strategy and Performance said that the report would reinforce that Boards should take into account Treasury Management advice and that Boards had responsibility for understanding the risks.
- 26/07/14 Income based risks included risks such as the impact of Welfare Reform, for example, the implementation of direct payments. Committee suggested that some narrative be added reflecting on the Scottish referendum and General electionoutcome and policy changes.
- 27/07/14 The Deputy Director Strategy and Performance confirmed that the publication of the report was planned for mid-September. Officers proposed that the draft report be sent to Members by email in the week commencing 16 August for comments and the final report be signed off by the Chairman.
- 28/07/14 Committee AGREED to the above process.

9 Consumer Regulation – Working with other Regulators and Annual Review

- 29/07/14 The Deputy Director Investigation and Enforcement introduced the report which sought Committee's approval for an approach to dealing with consumer regulation cases where other regulators were involved and presented the 2013/14 Consumer Regulation Review for approval.
- 35/07/14 Committee APPROVED the approach as set-out in the paper to consumer regulation where there are other regulators involved and AGREED that the final sign-off of the Consumer Regulation publication be delegated to the Chairman.

10 Value for Money Regulation in 2014/15

- 36/07/14 The Deputy Director Strategy and Performance gave an overview of the planned approach to evaluating the Value for Money statements for 2014/15.
- 37/07/14 He stated that there was an expectation that VfM statements for 2014/2015 would be qualitatively different from those received in 2013/2014.
- 40/07/14 It was AGREED that a workshop would be held for Members later on in the year

41/07/14 Committee AGREED the proposed approach and objectives for evaluating Value for Money in 2014/15.

11 Q1 Performance Report – 2014/15

- 42/07/14 Committee were invited to consider the quarter 1 business plan progress report and agree the mitigating actions for those targets which had amber status.
- 46/07/14 Committee NOTED the report.

12 Regulators' Code

- 47/07/14 The Head of Regulatory Framework and Performance introduced the report which updated Committee on the requirements of the new 'Regulators' Code' and the outcome of the government's proposals to introduce 'Small Business Appeals Champions'.
- 48/07/14 She explained that we have a duty to consider and comply with the Regulators Code when setting standards.
- 49/07/14 With regard to Small Business Appeals Champions and Non-Economic Regulators the Head of Regulatory Framework and Performance confirmed that government intend to introduce small business appeals champions via legislation to ensure that they have the appropriate powers and independence. The bill is at an early stage so may be subject to change.
- 50/07/14 Members requested that a monitoring report be brought back to Committee AS in April 2015
- 51/07/14 Members NOTED the report.

13 Tenanted disposals outside of the sector

- 52/07/14 The Registrar sought Committee's views on the disposal of tenanted social housing to unregistered commercial landlords and sought their agreement on the principles to be used when considering cases such as these.
- 56/07/14 Committee AGREED with the proposed principles and approach as set out by the Registrar.
