The licensing and registration requirements listed in this table are relevant to the precursor chemical listed and all mixtures and natural products containing them. It excludes:

- a. medicinal products as defined by Directive 2001/83/EC; & veterinary medicinal products as defined by Directive 2001/82/EC b.
- b. pharmaceutical preparations, mixtures, natural products & other preparations containing scheduled substances that are compounded in such a way that they cannot be easily used or extracted by readily applicable or economically viable means
