- 1. Any individual or company may obtain Plant Health Export Certification Services at reduced rates if:
 - that individual or company is not registered for VAT purposes;

OR

- the total value of the individual's or company's certified exports of plants and plant products was less than £5,000 during the last complete financial year (1 April to 31 March).
- 2. These concessions may also apply to private individuals making non-commercial exports and to Universities and other non-commercial scientific establishments.
- Services under this concession will be available only up to a maximum total of £750 at half price (£1500 full price value) in any one financial year. Services required when this total is exceeded will be charged for at full price.

- 4. Evidence of qualification will have to be provided by applicants if they are requested to do so.
- 5. If you think that you or your company qualify for export services at reduced rates, complete questions 1, 2 and 3 or 4 as appropriate, of this form, sign and date the application and return it to your local APHA Plant Health and Seeds Inspector.
