## 1. Introduction

### 1.1 Overview

Whenever an attempt is made to electronically file a tax form, a message should be returned to confirm the result of that attempt. This may take the form of either a success message, which confirms successful filing of that form, or a number of error messages. Error messages have two functions; to identify errors within the form itself and establish corrective action to be taken and to recognise errors within the connection, system or elsewhere which has prevented the form from reaching the validation stage.

### 1.2 Purpose and Scope

The response messages proposed in this document are intended to allow messages to be easily processed by Third Party software, while maintaining a degree of flexibility for changes to message handling in the future.

Further error codes have been included to allow meaningful HTTP error messages.

This document is applicable to both the test and the live service.

## 2. Response message

Response Messages can be broken down into two types, one of which will always be returned:

- Unsuccessful validation of a form, producing one or more error messages (contained within the one response).
- Successful validation of the form, producing one success message.

The success and fail response messages are output using slightly different message structures.

The differences are in the:

- contents of the **<Qualifier>** element. This will differ according to whether the response being returned indicates success or fail.
- use of the **<GovTalkErrors>** element.
- use of the **<Body>** element.

### 3. Messages

#### 3.1 Success Message

If a form is successfully filed, a response to this effect will be communicated via a success message. The following response will be produced if the form is successfully authenticated, validated and no errors have been produced during filing.

In the example above, the **<Qualifier>** element is set to “response”. This indicates that the form was successfully validated.

The **<GovTalkErrors>** element is not included, as there are no errors. .

## 3.2 Error Message

Unsuccessful filing could result from a number of reasons. It is required that a user is informed via a response message when faults occur during filing. This response will include both a message code and text to help identify the fault. The error responses generated, as a result of structure, data and business rules validation, along with the expected conditions that will produce them are shown in the following sections.

Note: Should the form produce more than one error, the **<Error>** element will be repeated (as shown above).

The <Error> element will contain additional attributes for non-schema enforced validation (i.e. bespoke validation), as follows:

The <ScheduleReference> element contains the actual form on which the error was encountered, e.g. SDLT1.

The <ScheduleOccurrence> element contains the occurrence of the schedule on which the error was encountered. This will always be 1 for Schedule References of SDLT1, but as multiple instances of SDLT2, 3 & 4 may be included within one submission, this will help locate which occurrence the error was encountered on.

The <GotoBoxNumber> element contains the box number (and part number if applicable) of the error encountered, e.g. 28.4 denotes box 28 part 4

In addition the <Location> element will contain the name of the element on which the validation failed (note this will not be the full Xpath to the element).

An example of the contents of the <Error> element for an error encountered from non-schema enforced validation follows, note that the aforementioned elements <ScheduleReference>, <ScheduleOccurrence> and <GotoBoxNumber> are enclosed by a parent <Application> element:

In the fail example on the previous page, the <Qualifier> element is set to "error". The <GovTalkErrors> element is included and indicates the error message was raised by "IR" and the error type is "business".

The <Body> element includes an <ErrorResponse> element, which wraps the actual error(s). Note the use of the <Application> element, which includes a <MessageCount>. The <MessageCount> element contains a count of the number of error messages contained within the body.
