

## CONDITIONS

1. Each consignment must be accompanied by a certificate signed by an Official veterinarian of the originating Channel Island stating:
  - a) Details of the number of doses, identification of donor animal, date(s) of collection, breed;
  - b) Name, address and registration number of the approved semen collection centre;
  - c) Place of loading
  - d) Place of destination
  - e) Means of transport
  - f) Names and addresses of consignor and consignee
  - g) Number and code-mark of semen containers

### General conditions

- a) The semen described above was collected, processed and stored in a semen collection/storage centre approved by the competent authority.
  - b) The semen described above was sent to the place of loading in a container sealed under official supervision.
  - c) The semen described above was collected from bulls resident in a country or region which is officially free of Foot and Mouth Disease.
  - d) The frozen semen was stored in approved conditions for a minimum period of 30 days immediately following collection.
2. **Health conditions of the donor animals**
    - (a) The semen described above was collected from bovine animals that have completed 28 days in quarantine premises that has been approved by the Competent Authority where only other cloven-hoofed animals having at least the same health status were present
    - (b) The donor bovine animals belong to a herd that is officially tuberculosis free, officially brucellosis free and officially free of enzootic bovine leucosis.
    - (c) The bovine animals have been subjected to the following tests within 28 days preceding the date of admission to a collection centre with negative results:
      - i. for bovine tuberculosis, an intradermal tuberculin test carried out in accordance with the procedure laid down in Annex B to Directive 64/432/EEC;
      - ii. for bovine brucellosis, a serological test carried out in accordance with the procedure described in Annex C to Directive 64/432/EEC;
      - iii. for enzootic bovine leucosis, a serological test carried out in accordance with the procedure laid down in Annex D (Chapter II) to Directive 64/432/EEC.

- (d) The donor bovine animals admitted to, and resident in, the centre have been subjected to the above tests at least once a year.
