

NOTICE OF ORDER WILDLIFE AND COUNTRYSIDE ACT 1981 SECTION 53

North Yorkshire County Council
The District of Craven (outside the Yorkshire Dales National Park)
Definitive Map and Statement
Footpath no 05.39/59, from Strikes Lane to Raven Stones, Sutton-In-Craven Modification Order 2011

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **16 April 2019**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by adding a footpath, commencing at the northern end of the public maintainable highway Strikes Lane at grid reference SE 0126 4356 (point A on the Order map), continues in a generally easterly direction for approximately 6 metres to a pedestrian gate at grid reference SE 0126 4356 (point B on the Order map), continues in a generally north easterly direction for approximately 58 metres to grid reference SE 0130 4360 (point C on the Order map), continues in a generally east north easterly direction for approximately 34 metres to a field gate at grid reference SE 0134 4361 (point D on the Order map), continues in a generally north easterly direction for approximately 26 metres to grid reference SE 0135 4363 (point E on the Order map), then continues in a generally east north easterly direction for approximately 192 metres to Raven Stones at grid reference SE 0152 4371 (point F on the Order map).

Timetable for sending in statements of case and comments

Within 2 weeks of the start date [by 30 April 2019]

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection

or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date [by 11 June 2019]

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date [by 23 July 2019]

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

This Order is made by North Yorkshire County Council under Section 53(2)(a) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the District of Craven (Outside the Yorkshire Dales National Park) Definitive Map and Statement require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely, the discovery by the authority of evidence which (when considered with all other relevant evidence available to them) shows that a right of way which is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to Section 54A, a byway open to all traffic.

The authority have consulted with every local authority whose area includes the land to which the Order relates. North Yorkshire County Council hereby order that:-

1. For the purposes of this Order the relevant date is 14 April 2011.
2. The District of Craven (Outside the Yorkshire Dales National Park) Definitive Map and Statement shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as "Footpath No 05.39/59, from Strikes Lane to Raven Stones, Sutton-In-Craven Modification Order 2011".

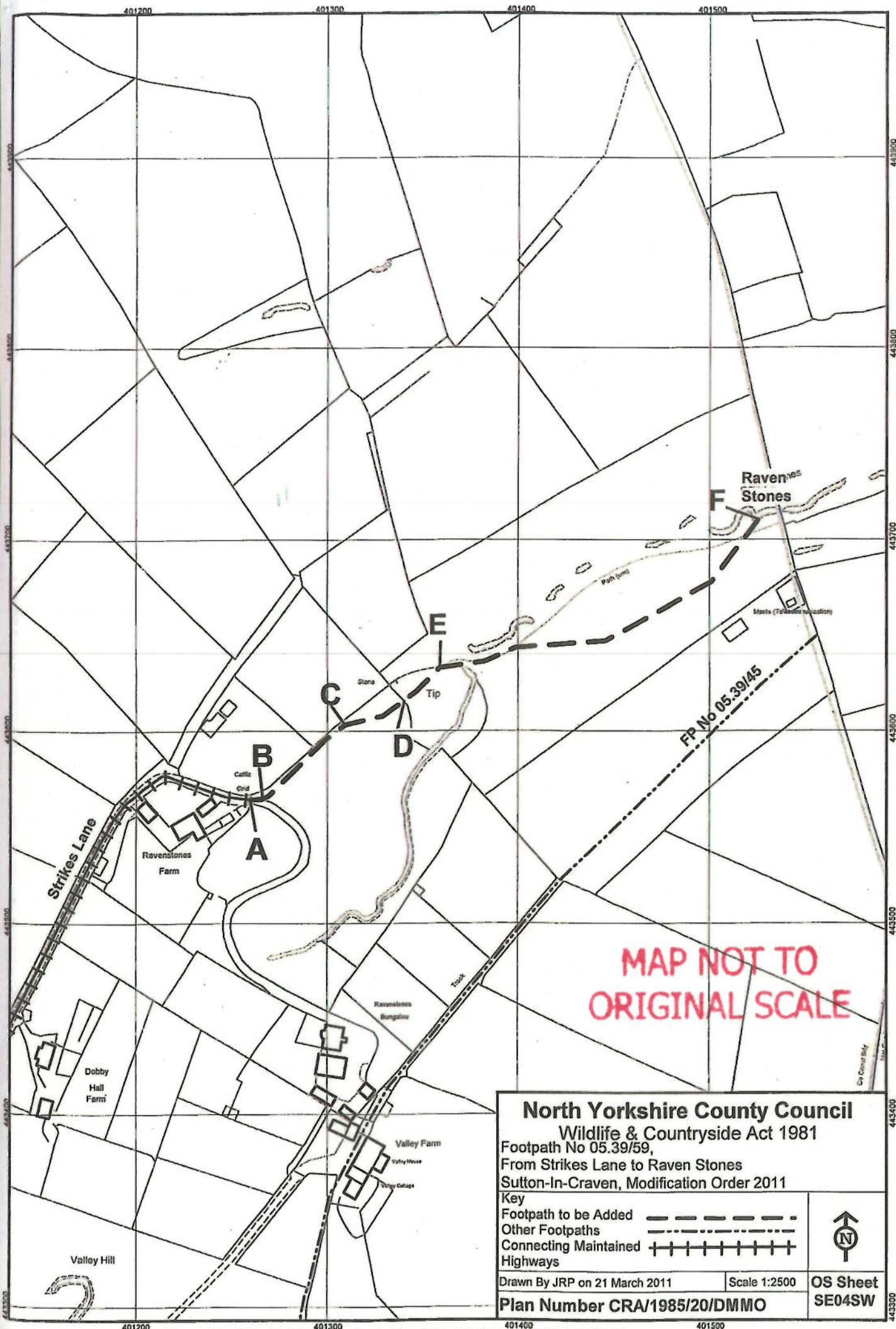
