



Global Goals Art Competition 2019

Have your artwork featured on the cover of the UK's first report of progress towards the Global Goals (also known as the Sustainable Development Goals or SDGs)

Eligibility

Open to children (aged 7-15) across the UK, the Global Goals Art Competition will aim to find a drawing or painting done by a child living in the UK that reflects the UK's contribution to the Global Goals (also known as the Sustainable Development Goals or SDGs) and what the Goals mean to them.

The theme of the competition is the Global Goals and we will advertise it across the UK.

The competition will open on 15 April and there are five weeks to submit an entry. The deadline for submissions will be <u>09:00 on 17 May 2019.</u>

The winner of the competition will have their artwork used on the cover of the UK's first Voluntary National Review report.

Entry

To enter:

- The artwork must be A4 in size.
- Scans or photographs of the artwork must be submitted in high resolution format (e.g. PNG / JPG).
- Artwork must be submitted to sdgs@dfid.gov.uk.
- A parent/guardian/school must submit the artwork on behalf of the child entrant with full permission of the entrant, including their consent to the terms and conditions below. Schools must also have obtained the consent of that child's parent or guardian.
- Only one submission of artwork per child.
- Please use the judging criteria below for guidance.
- The closing date for entries is 09:00 on 17 May 2019.

Terms and Conditions

By submitting a piece of artwork, the entrant is deemed to have understood and accepted the following terms and conditions:

- All artwork submitted must be the original idea and creation of the entrant and must **not** infringe anyone else's rights.
- The artwork must **not** contain any personal information.
- It is the entrant's responsibility to ensure that any person who appears in their artwork has given appropriate permissions for their image to be used in accordance with these terms.

- The winning entry will be used on the cover for the UK's Voluntary National Review report which will be presented to the United Nations in July and published online.
- By submitting artwork, all entrants (including the winning entrant and runners-up) provide their consent for their artwork to be used, free of charge, for other activity associated with the Voluntary National Review including, being published online, social media activity and for display, and other related activity after the Voluntary National Review is published.
- By submitting artwork, entrants and persons submitting on their behalf agree that Department for International Development (DFID) will use their personal information for administering this competition, press and advertising purposes, including publication (online or in printed form) of first name, age and broad location of the entrant alongside their artwork, and in accordance with our <u>Personal Information Charter</u> and <u>Privacy Notice</u>.
- Entrants agree to the cropping or other minor alterations to their artwork when used in accordance with these terms.

Advertisement of the Competition

The competition will be advertised in a number of ways including:

- Connecting Classrooms through Global Learning programme
- DFID's partner organisations for example, British Council and Project Everyone
- Department for Education digital channels, and Other Government Departments
- Devolved Administrations

Judging Criteria and Selection Panel

The theme of the competition is the Global Goals. The artwork can relate to the Global Goals and issues relating to the Global Goals such as sustainability or partnerships. We value all entries to the competition, unfortunately we will not be able to follow up directly with every entrant. The artwork will be judged based on the following criteria:

- Creativity and originality of the artwork
- The relevance to the Global Goals
- Interpretation of the theme
- Quality of overall design, colour and artwork

Background information on the Global Goals and the UK's Voluntary National Review

The 17 Global Goals for Sustainable Development (also known as the Sustainable Development Goals or SDGs) were adopted by all 193 United Nations member states in 2015. The Goals are part of the United Nations 2030 Agenda for Sustainable Development – a global agreement to eradicate extreme poverty and make the world a better place by 2030. The UK played a leading role in negotiating the Goals.

The 17 Global Goals seek to tackle a wide range of issues facing both developed and developing countries. The Goals include big issues like ending hunger, tackling climate change and achieving gender equality.

As part of the 2030 Agenda, the UK is reviewing its progress towards the Global Goals. We will submit this review to the United Nations in the form of a report called the Voluntary National Review. This is the first time the UK has prepared a Voluntary National Review and it will be presented to the United Nations in July, at the High Level Political Forum.
