The Armed Forces Covenant

The Armed Forces Covenant

An Enduring Covenant Between

The People of the United Kingdom
Her Majesty's Government

– and –

All those who serve or have served in the Armed Forces of the Crown

And their Families

The first duty of Government is the defence of the realm. Our Armed Forces fulfil that responsibility on behalf of the Government, sacrificing some civilian freedoms, facing danger and, sometimes, suffering serious injury or death as a result of their duty. Families also play a vital role in supporting the operational effectiveness of our Armed Forces. In return, the whole nation has a moral obligation to the members of the Naval Service, the Army and the Royal Air Force, together with their families. They deserve our respect and support, and fair treatment.

Those who serve in the Armed Forces, whether Regular or Reserve, those who have served in the past, and their families, should face no disadvantage compared to other citizens in the provision of public and commercial services. Special consideration is appropriate in some cases, especially for those who have given most such as the injured and the bereaved.

This obligation involves the whole of society: it includes voluntary and charitable bodies, private organisations, and the actions of individuals in supporting the Armed Forces. Recognising those who have performed military duty unites the country and demonstrates the value of their contribution. This has no greater expression than in upholding this Covenant.

Section 1: Principles Of The Armed Forces Covenant

1.1 We at the Veteran Group will endeavour in our business dealings to uphold the key principles of the Armed Forces Covenant, which are:

- *No member of the Armed Forces Community should face disadvantage in the provision of public and commercial services compared to any other citizen*
- *In some circumstances special treatment may be appropriate especially for the injured or bereaved.*

Section 2: Demonstrating our Commitment

2.1 The Veteran Group recognises the value serving personnel, reservists, veterans and military families bring to our business. We will seek to uphold the principles of the Armed Forces Covenant, by:

- ***Promoting the fact that we are an armed forces-friendly organisation;** which we will achieve through our commitment to promoting the full Armed Forces community both young and old throughout the region.*
- ***Seeking to support the employment of veterans young and old,** which we will achieve through our employment workshops aimed at helping service men and women making the transition and veterans looking for new pathways to employment.*
- ***Striving to support the employment of Service spouses and partners;** which we will achieve by working with them in and around their family commitments.*
- ***Endeavouring to offer a degree of flexibility in granting leave for Service spouses and partners before, during and after a partner's deployment;** which we will achieve as we have above by working with them in and around their family commitments.*
- ***Seeking to support our employees who choose to be members of the Reserve forces,** including by accommodating their training and deployment where possible; This will go without saying be one of the top priorities of our MD who himself is a reservist*

- *Offering support to our local cadet units, either in our local community or in local schools, where possible; The Veteran Group will actively look to support the RFCA wherever possible.*
- *Aiming to actively participate in Armed Forces Day; The Veteran Group will hold an event annually to support Armed Forces Day.*
- *Offering a discount to members of the Armed Forces Community; we are already looking at ways to not only provide discounts ourselves but also arrange other discounts in and around the region for Veterans and members of the armed forces.*
- *Any additional commitments The Veteran Group could make (based on local circumstances).*

2.2 We will publicise these commitments through our literature and/or on our website, setting out how we will seek to honour them and inviting feedback from the Service community and our customers on how we are doing.
