# **1. Scope of this call for user feedback**

Topic:	The Regulator of Social Housing (RSH) produces the publication and data: <i>Statistical Data Return (SDR): Private registered providers of social housing in England</i> in October each year. The publication covers the topics for which data is collected as part of the SDR data collection. Some of these data are also currently used and reported in other statistical bulletins published by the Ministry of Housing, Communities and Local Government (MHCLG).
	The full SDR data file is published at the same time as the publication document each year and includes the underlying data <sup>1</sup> provided to RSH via the SDR collection. Additionally, since 2018 we have included two look-up tools which allow users to interrogate the data set at either a provider level or at a geographic (local authority) level.
Scope:	This paper calls on users of the SDR and other stakeholders to provide views on the proposals outlined and answer questions about their use of the SDR publication, data files and look-up tools to help the RSH improve the way in which data are published and better meet user needs now and, potentially, in the future.
	The outcome of this review will inform the next SDR publication due for publication in autumn 2019. A chance to provide views on the 2019 release will be provided following its publication.

RSH will not publish any individual responses but will summarise these at a high level in the outcome from the review, published in summer 2019.

However, RSH is subject to the Freedom of Information Act (FOIA) and the Environmental Information Regulations 2004 (EIR). Therefore, information provided in response to this call for views may be made available in accordance with either statute.

RSH has a statutory obligation to respond to all requests for information. To inform our responses, we consult with third parties where applicable and appropriate. Additionally, you should indicate any areas of information that you believe are particularly sensitive when submitting your response.

The Regulator will take a proportionate approach to its equality obligations and has identified no specific equalities implications for this call for user feedback. However, based on responses, RSH reserves the right to revisit these matters if new information comes to light.

## 4. Background

Since 2012 RSH has collected a large amount of information from private registered providers<sup>3</sup> (providers) of social housing through the SDR data collection. This annual survey (collected in April and May) collects data on housing stock owned by providers, much of which is collected at a local authority level, including number and size of dwelling and average weekly rents. The survey also collects information on the gains and losses from the social housing sector, with a balance sheet introduced in 2017 providing greater insight into the way in which stock moves around, in and out of the provider ownership.

This data is published in autumn alongside a statistical publication, which provides additional information and insight on the data collected and the trends which it suggests regarding changes in stock owned, rent levels and activity within social housing owned by private registered providers.

Over the last few years the size of the publication has increased (to nearly 90 pages in 2018), in response to increased complexity in the policy environment and diversification in the social housing sector. Feedback from some users has suggested that the increase in the size of the document has made it more difficult for users to navigate and to identify key data and trends. Some users have suggested that they do not make extensive use of the full statistical publication. The size of the publication and associated analysis has also increased the amount of time and resource required to reach publication, pushing the publication time back by over a month since 2012. Delays in publication of key data can reduce their value to some users.

RSH has already been working to improve the SDR publication, based on feedback we have received, with the introduction of the look-up tools in 2018, allowing easier access to, and instant presentation of, the SDR data on a provider and geographic (local authority) basis. It is now seeking user views on how further changes and improvements could be made to the way the SDR data and publication are presented and disseminated.

The RSH will begin a pilot data collection (Local Authority Data Return (LADR) from 2019, however data from this collection will not be published by the RSH but will be included alongside data collected through the LAHS return by MHCLG.

# 5. Proposals

RSH is seeking user views into the future of the SDR publication and data release to ensure the SDR delivers usable, effective and reliable statistical data to those interested in social housing provision by private registered providers.

The key change proposed would be to replace the current large SDR publication with smaller, individual briefing notes about key topics that are believed to be the most useful and most used (based on previous feedback).

Alongside each of these shorter briefing notes we would propose the publication of the key data fields to which they relate, with the full data set being published shortly after the publication of these notes along with the look-up tools.

By creating shorter briefing notes and focusing analysis on the key areas of interest we aim to make the publication of the data timelier; achieving the publication of stock and rent information in late September with the full set of data being available from early October. Users have suggested that it is valuable to be able to access these data by this stage, particularly to inform rent setting and provider business planning decisions for the following financial year.

The SDR data would also still be available through other MHCLG publications, including the live tables at the point they are published (usually from November each year).

#### **Overview of proposed changes**

The table below outlines the key proposals for the publication of the SDR from autumn 2019.

However, if key changes occur within these thematic areas then additional briefing notes could be produced on an ad hoc basis.
Additional tables	Additional tables – Greater range of tables, covering all those currently available in the SDR publication document.
	Additional maps – showing key themes on a larger scale than those included in briefing notes (including those within the current SDR publication).

Missing or late submitters list and pre- release access notes	These would remain the same. Published alongside the first data released.

Once the data is interrogated we may consider whether it is appropriate to produce additional briefing notes to explain trends or changes within the data submitted. These would be published following the publication of the core data and key briefing notes.

### **Timing of proposed changes**

RSH will publish the outcome of this review and the call for user views in the summer 2019.

Following this, the 2018/19 SDR data will be published in the autumn in the format determined by RSH after taking into account user feedback. Specific publication dates will be determined in the summer – we anticipate the release of the three core briefing notes and full data set no later than the current timetable, which sees the publication occurring at the end of October each year.

Users will have the opportunity to provide further comment on any revised release following the autumn publication.

## 6. Suggested questions on proposed changes

We would like to know what you think of the proposed changes outlined in section 5 of this document. In addition, we would welcome views on the following allied questions:

- 1. What use do you currently make of the SDR publication document, and would anything be lost if the large publication was no longer available in future (given that all underlying data and short briefing notes would still be published)?
- 2. Are the key topics we've suggested (stock levels, rents and stock movement) the most appropriate areas for briefing notes? Are there other areas of the SDR data you would like to see analysed and published in briefing note format?
- 3. Do you have any concerns or comments on the proposal to remove commentary on vacancies, sector characteristics, Decent Homes Standard, Evictions or Mutual exchanges (noting that data and tables would still be published)?
- 4. At what time of year is the SDR information most valuable to you? Is the proposed acceleration of the timetable for stock and rent data likely to be helpful?
- 5. Are there any other additional tables or cuts of the data that you would like to see which are not currently available?
- 6. Are the maps that are currently produced of use to you? Are there other graphical representations of data you would be keen to see?
- 7. Do you find the current publication of the full SDR data file in one excel file helpful, or are there any other formats that you would prefer or be more useful?
- 8. Have you used the PRP look-up tool in 2018, if so was it useful? Are there any improvements you'd like to see in the provider look-up tool?
- 9. Have you used the LA look-up tool in 2018, if so was it useful? Are there any improvements you'd like to see in the LA look-up tool?
- 10. Do you have any views on the intended addition of regional summaries to the current geographic (local authority) look-up tool?
- 11. Do you have any views on the proposal for a regional/LA trend look-up tool (likely to be published in 2020)?

#### **General comments about the statistics**

We would also like to hear any general comments you have regarding the Statistical Data Return. In particular:

- Is there anything we currently do which you would not want changed, and if so why?
- Is there anything that the figures do not cover which you would find useful, and if so why?
- Are there any other suggestions you have which you think could improve the publication of the SDR data, and if so why?
