Thank you for your emails of 7 May in which you requested the following information:

the total number of soldiers in the Staff and Personnel Support (SPS) branch of the Adjutant General Corp(AGC) that were made redundant between 2010 and 2015 in rank categorisation?

I am treating your correspondence as a request for information under the Freedom of Information Act (FOIA) 2000. A search for the information has now been completed within the Ministry of Defence (MOD), and I can confirm that information in scope of your request is held and has been provided below. Some of this information is exempt from release under section 40 (Personal Data) of the FOIA. Section 40(2) has been applied to some of the information to protect personal information as governed by the Data Protection Act 2018. Section 40 is an absolute exemption and there is therefore no requirement to consider the public interest in deciding to withhold the information.

Numbers of Trade Trained Regular Personnel in the Staff and Personnel Support(SPS) Branch of the Adjutant General Corps(AGC) leaving the Army with an exit reason of "redundancy" between at 1st April 2010 - 31st March 2016 are shown in the table below:
