Thank you for your email received by the Ministry Of Defence on 29/01/2019 requesting the following information:

"Can you kindly send me the most recent estimate of the number of UK Forces children."

We are treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

We have now completed a search for the information you requested, and I can confirm that all information in scope of your request is held and is provided in Table 1.

Table 1: Estimated¹ Number of Children of UK Regulars² as at 1 January 2019

Total number of children	103,620
Children under 18	90,020
Children 18 and over	13,600

Notes:

- 1. The figure is an estimate because the 'children' field that we use has not been validated. It is a field that Service Personnel fill in themselves in the Joint Personnel Administration (JPA) system.
- 2. UK Regulars comprise Full-time Service Personnel, including Nursing Services, but excluding Full Time Reserve Service (FTRS) personnel, Gurkhas, mobilised Reservists, Military Provost Guard Service (MPGS), Locally Engaged Personnel (LEP), Non Regular Permanent Staff (NRPS), High Readiness Reserve (HRR) and Expeditionary Forces Institute (EFI) personnel. Unless otherwise stated, includes trained and untrained personnel.
- 3. The figures have been rounded to the nearest 10.
