PROVISION OF REQUESTED INFORMATION

Thank you for your request for information on pay brackets of APHA staff which we received on 14 August 2018. Your request has been handled under the Freedom of Information Act 2000 (FOIA).

The information you requested and our response is detailed below:

'I recently sent out a round of FOIs on how many staff were on pay packets worth over £100k for your organisation, broken down by year.

1) That the executives named in accounts are the only staff members that would have been on pay deals worth £100k+?

We can confirm that the only staff members on pay deals of £100k+ are specified in the accounts.

2) If you are able to provide the total number of staff over £100k for just the years 2013/14 and last financial year 2017/18 - or at least confirm again that any data pulled from the accounts covers all staff in that pay bracket, not just the execs.'

We can confirm that the accounts covers all the staff in the pay bracket requested. In 2013/14 there was 1 employee and in 2017/18 there were 3 employees.

Information disclosed in response to this FOI request is releasable to the public. In keeping with the spirit and effect of the FOI and the government's Transparency Agenda, this letter and the information disclosed to you may be placed on GOV.UK, together with any related information that will provide a key to its wider context.
